Instruction to the Candidates participating in Round-3 of Tripura State NEET PG 2024 Counselling.

- 1) Candidates are instructed to fill in **all their desired choices** during the choice-filling process for Round 3 of Tripura State NEET PG 2024 Counselling, **regardless of the published seat matrix**. Choices made in Round 1 or Round 2 shall be considered null and void.
- 2) Once a candidate upgraded a seat in Round-3, previous admitted seat in Round-1 or Round-2 (if any) shall automatically get cancelled.

- 3) Candidates are instructed to follow the website of allotted Institutions for details regarding admission and other details.
- 4) If a candidate is allotted a seat in Round-3 counselling and **does not join** to the admitting institute, then the candidate will be **exited with forfeiture of security deposit and eliminated** for participating in any further rounds of counselling.
- 5) If a candidate is allotted a seat in Round-3 counselling and joined the admitting institute, then he/she **CANNOT** upgrade or resign.
