As per the Notice No.15, the Schedule for Online Stray Vacancy round was postponed due to reduced qualifying criteria for admission to Post Graduate Medical Course by NBE, New Delhi. In view of the lower down of qualifying criteria, the competent authority has now decided to start the registration process to allow the newly qualified candidates to participate in the ongoing process.

❖ **Important Instructions for candidates**

- 3) Candidates should ensure they have all the necessary documents for category claim as per the information brochure and they should be in prescribed format only. Especially for EWS candidates, the format as per **Annexure A** is only valid and **Annexure I** will not be considered for admission through State Quota.
- 4) Candidate should ascertain the fees for the unaided private college well in advance through the concerned college website or Fees Regulating Authority (FRA) website before filling up the choices.
- 5) **Candidates claiming PWD quota should have certificate issued by any one of the authorized boards in Online format. Certificate from any other authority will not be considered.**
