Notice for Stray Vacancy Round Online Counselling

In continuation to Adv. No.BCECEB(PGMAC)-2024/01 & 2024/02 dated: 03.11.2024 and 2024/11 & 2024/12 dated: 08.01.2025 for admission in Govt. as well as Pvt. Medical Colleges of Bihar on vacant seats of MD / MS / PGD / DNB (Degree & Diploma) Courses after admission on the basis of PGMAC-2024 Round-3 Counselling which was held from 05.02.2025 to 08.02.2025, this is to informe that Candidates who have duly filled the online application form for PGMAC-2024 vide Adv. No.BCECEB(PGMAC)-2024/01 & 2024/02 dated: 03.11.2024 and 2024/11 & 2024/12 dated: 08.01.2025 and found eligible as per Revised cut-off percentile and do not come under the points mentioned below in Not Eligible Criteria are eligible for participating in Stray Vacancy Round Counselling of PGMAC-2024.

- 2. Candidates are advised to download their Rank Card of PGMAC-2024 by clicking the link "Rank Card of PGMAC-2024 (for Stray Vacancy Round)" by submitting their PGMAC ID and Date of Birth.
- 3. The candidates who fall under below mentioned conditions are **not eligible** to participate in Stray Vacancy Round Counselling of PGMAC-2024 based on NEET(PG)-2024:
 - (a) Admitted on PG Medical seat through PGMAC-2024 Round-1 / Round-2 Counselling.
 - (b) Allotted through PGMAC-2024 Round-3 but not joined their allotted seat due to any reason.
 - (c) Admitted through AIQ on the basis of NEET (PG)-2024 Round-1 / Round-2 / Round-3 Counselling.
 - (d) Allotted through AIQ on the basis of NEET(PG)-2024 Stray Vacancy Round Counselling.
- 4. The updated Seat Matrix for UGMAC-2024 Counselling has been uploaded on Board's Website. The candidate must see it before filling up of their Choices for Online Counselling.
- 5. Candidates are advised to fill choices keeping in mind that virtual vacancy may arises due to upgradation.
- 6. Stray Round Vacancy Counselling will be conducted Online.
- 7. After downloading the rank card, eligible candidates will have to do online Registration-cum-choice filling for online counselling. For online choice filling, all eligible candidates are required to click on link ''Online Counselling Portal of PGMAC-2024''. After clicking the link candidates are advised to do the registration for online counselling by submitting the data as asked on the computer screeen.
- 8. All such eligible candidates whether he/she is admitted on the basis of Round-3 Counselling / not allotted / not participated in previous rounds of PGMAC-2024 will have to give their Willingness for participating in Stray Vacancy Round Counselling by login to their account through online counseling portal. After giving Willingness they have to fill fresh Choices.
- 9. Such candidates who are admitted through Round-3 Counselling and given their Willingness for participating in Stray Vacancy Round Counselling will also have to fill fresh Choices as their previous filled choices will become null & void except their Round-3 allotted choice. Candidate will have the facility to add / remove choices By keeping their allotted choice intact i.e. they shall not have the facility to remove their Round-3 allotted choice.
 - (a) If candidate does not add any choice then their previous allotted choice i.e. Round-3 joined seat will remain retained.
 - (b) If candidate add choices and their choices do not get upgrade then their previous allotted choice i.e. Round-3 joined seat will remain retained.
- 10. Candidates who have filled choices for Round-3 counselling but had not been allotted any seat from Round-3 Counselling and given the Willingness for participating in Stray Vacancy Round Counselling will have to fill fresh choices as their previous filled choices gets 'Null & Void", It is mandatory to fill fresh choices.

- 11. Candidates who have given their Willingness for participating in Stray Vacancy Round Counselling and had not done choice filling for any of the previous rounds will have to do fresh Registration-cum-choice filling. They will also have to fill fresh choices mandatorily.
- 12. For Choice filling, candidates are required to do the registration for password creation on counselling portal. Then using their User ID & Password login in their account, candidates have to fill in choices of Course and Institution / Colleges in order of preference. Once choices are filled in, it can be modified before locking it. For this candidates have to click on "Unlock Choices" button after authentication / verification of obtained OTP on their Registered Mobile no. and email, and can modify their choices till last date of choice locking. During the choice locking period it is necessary to lock the choices to get a print of their submitted choices. If candidate does not lock the choice submitted, their choice will be automatically locked on notified date at notified time, however candidate will be allowed to take a print of their choices after locking, but he / she will not be permitted to modify choices after locking.
- **Note:** Registration for Choice filling, Choice locking & unlocking process will be done through OTP authentication only which will be sent on Registered Mobile & email of the candidates which can not be changed in any circumstances.
- 13. The list of finally filled in choices will be sent to candidates on their Registered email ID before seat allotment result.
- 14. The seat allotment will be done on merit-cum-choice basis. Provisional seat allotment order will be made available on Board's website on **26.02.2025**.
- 15. All eligible candidates are advised to login their account in schedule period of date & time and view the provisionally allotted seat result and download their provisional allotment order.

In case candidate is allotted seat in Stray Vacancy Round Counselling, he/she has to report physically at reporting centre for Document Verification / Admission as per programme given below and as per rule mentioned in PGMAC-2024 Prospectus.

- 16. The candidate who will be allotted seat in Stray Vacancy Round will be treated as admitted and if he / she does not take admission on allotted seat of Stray Vacancy Round or his / her seat gets cancelled due to any kind of Discrepancy, his / her Security Deposit Amount will be **forfeited** as well as he / she will not be eligible for further round counselling (if conducted) and the allotted data will be shared with MCC as per MCC rules.
- 17. Such candidates who have been allotted a seat in Round-3 Counselling and successfully completed the document verification process but their allotted seat gets cancelled due to any kind of discrepancy are also not eligible for Stray Vacancy Round Counselling as well as their Security Deposit Amount has also been get **forfeited**.
- 18. In case of any discrepancies, the Rules and Regulations of MCC (PG Counselling) / PGMAC-2024 Prospectus will be followed.
- 19. Eligibility criteria and instructions and other details are available in the Updated Prospectus of PGMAC-2024 which can be downloaded from the Board's website beceeboard.bihar.gov.in.
- 20. Seat Matrix of vacancies after completion of Round-3 Counselling will be available on Board's website from **20.02.2025**. If any further vacancies arises, the Seat matrix of updated vacancies shall be uploaded on the Board's website before start of Stray Vacancy Round Counselling.
- 21. Board will not be responsible for any interruption in Internet / Banking system. Therefore the candidates must not wait for last date and complete all procedure before due date.
