# **Notification on Free Exit**

#### Phase-1/Phase-2 PG Seats under Competent Authority Quota (Non-Service) and Management Quota for the Academic Year 2024-25

As part of the University Counselling process for admission to PG (Medical) courses under Competent Authority Quota and Management Quota for the academic year 2024-25, the following guidelines regarding the *Free Exit* facility are hereby notified:

#### 1. Free Exit Provision

- a) Candidates joined the PG seats through State Counselling (both Competent Authority Quota and Management Quota) in Phase-1/Phase-2 can avail of the *Free Exit* option.
- b) The University is open to considering an extension of the *Free Exit* timelines for AIQ Round 3 allottees.
- c) The resignation facility for availing this option will be available:
  - From: 01:00 PM on 25.01.2025 (Saturday)
  - Until: 03:00 PM on 28.01.2025 (Tuesday)

### 2. Procedure for Free Exit

- a) Candidates must visit their allotted college to resign from the Phase-1/Phase-2 joined seat and submit an undertaking to this effect in the format annexed to this notification.
- b) College Principals are responsible for ensuring that all resignations are promptly entered into the college login system.
- c) Additionally, the college Principals must update the data by 04:00 PM on 28.01.2025 in their logins, download and email a signed copy of the reported/not-reported and resigned candidates list along with the **student undertaking** to appgadmissions2021@gmail.com.
- d) College Principal shall return all the Original Certificates and the tuition fee and other fee collected, to the candidates' who resign from their seat.
- e) Failure to complete this process will render the resignation as 'Null & Void'.

#### 3. Important Guidelines for Candidates

- a) Utilize the *Free Exit* facility strictly within the stipulated time.
- b) Once the *Free Exit* option is availed, the vacated seat will no longer be claimable by the candidate and will not be available for selection in Phase-III counselling.
- c) Resigned candidates are eligible to participate in Phase-III Counselling as per eligibility.
- d) Vacancies resulting from *Free Exit* will be included in the Phase-III counselling process.
- e) Candidates who wish to participate only in MQ Phase-III and currently hold a CQ seat from Phase-I/Phase-II must resign from their CQ seat **before the commencement of CQ Phase-III counselling** as per this free exit notification. As Candidates allotted/upgraded in CQ Phase-III irrespective of their reporting status will be <u>blocked</u> from participating in MQ Phase-III counselling, even if they have exercised web options.
- f) The rules of Phase-III will be applicable to all the candidates holding a seat under CQ in Phase-I/Phase-II, who do not opt to EXIT as per this Notification.
- Reported candidates who have not availed the free exit option within the schedule announced <u>as per</u> <u>this notification</u> will not be permitted to resign from their allocated seat during the admission process. However, they may choose to discontinue the course after the admissions process concludes, subject to payment of a discontinuance fee of ₹3 lakh plus 18% GST as per Rules.

# 5. Restrictions and Penalties

- a) **No Extensions:** Requests for extending the <u>*Free Exit*</u> deadline will not be entertained under any circumstances.
- b) **Dual Reporting Prohibited:** Candidates are strictly prohibited from reporting both in, State Quota in any other State's Counselling Allotment or AIQ.
- c) Any instances of dual reporting will attract severe penalties, including potential disqualification.

Candidates are encouraged to carefully follow the above instructions to ensure a smooth process.
