Online Stray Vacancy Round seat allotment – PG Medical 2024

PG Medical seats which are cancelled after PGET-2024 Mop-up round are being published on the KEA Website. These seats will be considered for allotment in the Stray Vacancy Round along with the seats which have remained unfilled after mop-up round.

 CAUTION DEPOSIT: From 11.00 am on 21-02-2025 to 24-02-2025 - 2.00 PM (NEFT / RTGS/ ONLINE)

Candidates who are willing to participate in the PGNEET 2024 Stray Vacancy Round should pay **CAUTION DEPOSIT** of Rs.5,00,000/- (Five Lakhs). If a candidate gets the PG Medical seat, Caution Deposit will be adjusted towards the fee. If a candidate gets the PG medical seat in the Stray Vacancy Round and fails to report to the college, or fails to take admission in the allotted college or likes to cancel the seat, **CAUTION DEPOSIT** will be forfeited. (Candidate also has to pay the penalty amount as per rules — and the candidate will be barred from participating in the counselling including AIQ in the coming year) (List of not paid candidates will be sent to MCC)

- 2. Eligible candidates: Eligibility to participate in the Stray Vacancy Round is as per the criteria stipulated by MCC in their notification dated 14-02-2025 as interpreted by the Hon'ble High Court in WP No. 4723/2025.
 - (a) Candidates who are not holding the seat allotted in First Round or Second round of KEA or MCC or other state counselling and candidates not allotted seat in MCC Round-3 or in the Stray Vacancy Round are only eligible to participate.
 - (b) Candidates allotted pre and para clinical seat can participate in Stray Vacancy Round for Clinical seats only.
 - (c) * As per the orders of the Hon'ble High Court in WP no. 2848 / 2025, candidates who have been allotted in KEA Mop-up round can participate in the Stray Vacancy Round with the following conditions.
 - * Hon'ble High Court order in WP no. 2848 / 2025
- (a) Candidates who have paid the fees and joined the colleges after allotment of seats in mop-round should get registered themselves compulsory by paying Rs.500/- through online from 21-02-2025 to 23-02-2025 to confirm their participation in the Stray Vacancy Round; such candidates will only be considered for Stray Vacancy Round; and such candidates,

- (b) have already paid the fees in the Mop-up round and participating in Stray Vacancy Round with new registration, they need not to pay Caution Deposit; and such candidates;
- (c) have to enter the options afresh, seat allotted in the Mop-up Round will be considered as last option. If any seat gets allotted among the priority of options entered by them, they should report to the newly allotted college or if seat is not allotted then the seat allotted in the mop-up round will be retained. (If the newly added option gets allotted they lose their old seat. If none of the seats are allotted then the candidate's earlier seat is retained.) (Candidates are advised to participate in this stray vacancy round with utmost care and options should be entered carefully)
- 3. Entry of options: From 4.00 pm on 20-02-2025 to 24-02-2025 upto 2.00 pm
 - (a) All eligible candidates have to enter the options afresh.
 - (b) While entering the options verify and confirm the fee structure and then enter the options.
 - (c) Candidates are also advised to enter the options by keeping in the mind the penalty to be paid in case of not joining / cancellation.

NOTE: Candidates will be considered for allotment only after confirmation of CAUTION DEPOSIT and options.

Any cancellation or surrender of seats after the mop up round shall be made in person only to the Director, Directorate of Medical Education, Karnataka with a penalty of Rs 18,00,000/-(Rupees eighteen lakks only) in case of Medical Clinical Degree or Diploma Courses.

Provided that,-

- (a) A candidate who has opted Pre-Clinical seats like Anatomy, Physiology and Biochemistry including Forensic Medicine in the event of cancellation shall pay a penalty of Rs. 1,00,000 (Rupees One Lakh only) and the fees paid shall be forfeited;
- (b) A candidate who has opted Para Clinical Seats like Pharmacology, Pathology, Microbiology and Community Medicine, in the event of cancellation, shall pay a penalty of Rs. 2,00,000/-(Rupees Two lakhs only) for post graduate degree courses and Rs. 75,000/- (Rupees Seventy thousand only) for post graduate Diploma courses and the tuition fees paid shall be forfeited.

In addition to the prescribed penalty under sub-rule (4), all candidates (including in-service candidates) shall pay the entire course fee and stipend to the respective Medical/Dental colleges in the event he leaving the course before its completion.

- 4. Publication of provisional seat allotment results: 24-02-2025 after 8.00 pm
- 5. Publication of final seat allotment results: 25-02-2025 after 11.00 am
- 6. Payment of fees: 25-02-2025 to 28-02-2025 (up to 12.00 Noon)
- 7. Last date for reporting to the college: 28-02-2025 (As per MCC Schedule date cannot be extended further)
