### \* Important Instructions for candidates

- 3) Candidates should ensure they have all the necessary documents for category claim as per the information brochure and they should be in prescribed format only. Especially for EWS candidates, the format as per Annexure A is only valid and Annexure I will not be considered for admission through State Quota.
- 4) Candidate should ascertain the fees for the unaided private college well in advance through the concerned college website or Fees Regulating Authority (FRA) website before filling up the choices.
- 5) Candidates claiming PWD quota should have certificate issued by any one of the authorized boards in Online format.Certificate from any other authority will not be considered.
