**(After Lowering of NEET PG 2025 cut-off percentile)**

**Notification for exercising web-options for Additional Mop Up phase of counselling for admissions into PG Medical courses under Competent Authority Quota for the AY 2025-26.**

In continuation to this office notification dated: 30.09.2025, 12.11.2025, 03.12.2025, 10.12.2025, 14.12.2025, 17.12.2025, 21.12.2025, 25.12.2025, 27.12.2025, 16.01.2026, 17.01.2026, 27.01.2026, 28.01.2026, 06.02.2026, 10.02.2026, 11.02.2026 & 16.02.2026, KNRUHS hereby notifies to conduct Additional Mop up phase of web-based counseling for allotment of the Post Graduate Medical seats.

Candidates whose names are notified in the Final Merit list of PG Medical Admissions on the KNRUHS website on 11-02-2026 are eligible to exercise web-options online from computer with internet connection subject to following conditions:

1. The Candidates who were allotted seats under Competent Authority Quota in the previous phases of counseling and have not reported/discontinued the course after joining at the respective college are not eligible for exercising web-options.
2. Candidates who have not exercised web options in the first phase of counseling are also not eligible to exercise web options.
3. The candidates who were allotted PG Medical seats in the previous phases of counseling and joined the course and continuing the course are eligible to exercise web options.
4. **Candidates who are notified in the admitted candidates list under All India Quota after 3<sup>rd</sup> round are not eligible to exercise web-options.**
5. **Candidates are hereby informed that the list of admitted and allotted candidates after additional Mop-Up phase of counselling shall be forwarded to MCC for excluding them from Stray Vacancy round conducted by MCC. Accordingly, candidates should exercise web options carefully to courses and colleges they are interested to join with awareness of this fact.**

6. **If a candidate is allotted a seat in this phase of counselling and does not join the course, he will be liable for payment of penalty of Rs. 50,00,000/- (Rupees Fifty Lakhs only) to KNRUHS and also shall be debarred for 3 years from PG Medical admissions under KNRUHS.**

Eligible candidates can exercise web options as per eligibility for admission into vacant PG Medical Non-service Quota seats & newly added seats from **05.00 P.M. on 19-02-2026 to 11.00 A.M. on 20-02-2026** through website <https://tspgmed.tsche.in>

For eligibility criteria and regulations refer to notifications dated: 30-09-2025.

**UNIVERSITY FEE:** Allotted Candidates have to pay University fee of Rs.29,600/- by way of online payment gate-way and download the allotment letter. Candidates who have already paid University fee in previous phase need not pay again.

**TUITION FEE:** Tuition fee is to be paid at respective Medical colleges. The tuition fee payable as notified by Government of Telangana in G.O.Ms. No. 107 HM& FW(C1) Dept. Dated: 28.07.2023 (notified on website).

The allotment of seats will be made in accordance with the existing Government orders and relevant Hon'ble Supreme Court and Hon'ble High Court orders.

**IMPORTANT NOTE: All the candidates are hereby informed that the allotments and admissions are subject to the orders of Hon'ble Supreme Court and Hon'ble High Court in pending cases.**

**Instructions to Candidates:**

- 1) The details of vacant seats (seat matrix) including newly added clinical seats at MNR Medical College & Hospital, Sangareddy and Nizam's Institute of Medical Sciences, Hyderabad are placed in the website <http://knruhs.telangana.gov.in> . Candidates can exercise web options for vacant seats in all Medical Colleges affiliated to KNRUHS & NIMS through <https://tspgmed.tsche.in> as per eligibility.
- 2) Competent Authority Quota seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. Muslim Minority Candidates are also eligible for Competent Authority Quota seats in other Medical Colleges.
- 3) In case of non-availability of candidates or web-options for reserved category seats, they will be converted as notified in G.O.Ms.No. 155 and allotted at the end of this phase of counselling.

- 4) Candidates are advised to go through the prospectus of KNRUHS and the Government orders on Rules of PG admissions available on website before exercising web options for the regulations.
- 5) Candidates exercising web-options for PG Medical courses are informed that there is no limit of choices (number) for exercising web-options. Candidates can exercise web options for any number of subjects and colleges the candidate is interested to join as per candidate's eligibility.
- 6) Candidates are advised to exercise web options for PG seats in all courses and colleges in which they are interested to join irrespective of available vacant seats shown in the seat matrix, as vacancies may arise during counseling process due to sliding of candidates from allotted seats in previous phases of counseling to other seats as per their web options in the Mop up phase of counseling. **If candidates are not interested to join in any subject or college, they should not exercise web options for the same.**
- 7) If PG seat is allotted in this phase of counseling as per web options exercised by the candidate, the seat allotted in previous phase of counseling will be automatically cancelled and allotted to the other candidate. Therefore, the candidates are informed to exercise web options carefully for sliding with awareness of this fact.
- 8) Candidates can exercise options on the web through a computer having internet facility.
- 9) One Time Password (OTP) will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options).
- 10) Candidates are instructed to take a print out of saved options.
- 11) Candidates will receive SMS message on their registered mobile after allotment of seat, if allotted. Candidates are also directed to check their allotment status on <https://tspgmed.tsche.in> website after each phase of counseling without fail.
- 12) The selected candidates shall download the allotment order from website after payment of the University fee by payment gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates should check their allotment details and report to the Principal of respective Medical College on or before the last date specified on the allotment order.
- 13) Selected candidates have to report at the respective Medical Colleges before the last date for joining as specified on the allotment order, submit all original certificates,

custodian certificate (if joined in previous phases), relevant bonds and pay the tuition fee / college fee to complete the process of admission. If the candidate does not fulfill the above criteria to complete the admission process within the specified date, the admission will be cancelled automatically and the candidate will be considered as being part of seat blocking and **candidate has to pay penalty of Rs. 50 lakhs and also debarred for 3 years for PG Medical admission under KNRUHS.**

- 14) **Candidates who were allotted seats in this phase of counselling are not eligible to exercise web-options in Additional Mop-Up Phase of counselling under Management Quota and stray vacancy phase of counselling under Competent Authority Quota and Management Quota for the AY 2025-26.**
- 15) If the candidate slides to other college during Mop up phase of counseling, the candidates have to get relieved from previous phase joined college, collect custodian certificate, fees and report to the Principal of allotted college before last date of joining.
- 16) Candidates are hereby informed that final verification of original certificates will be conducted at the allotted college and in case of any discrepancy, the provisional allotment will be cancelled and action shall be initiated as per University Regulations.
- 17) As informed earlier, admitted candidates are not permitted to withdraw from the course after free exit.
- 18) The University fee and other fees once paid shall not be refunded under any circumstances.
