Online Registratin and CAP Round -3 Schedule for BAMS/BHMS/BUMS (Group B) courses A.Y.2025-26

In continuation of the Admission Process for BAMS/BHMS/BUMS (Group B) Courses for Academic Year 2025-26, it is hereby notified that the Centralised Admission Process (CAP) Round - 2 has been completed as on 10/10/2025, as per Notice No. 13, dated 26/08/2025.

The seats remaining vacant after CAP Round -2 will be filled through the next subsequent round (CAP Round - 3) in accordance with the provisions of the Information Brochure.

Accordingly, the Competent Authority, State CET Cell, Maharashtra State, has decided to conduct Registration and CAP Round - 3 for BAMS/BHMS/BUMS (Group B) Courses as per the schedule given below:

Important Instructions for State Counseling

- 1. Candidates who have already registered need not register again.
- 2. Candidates who have Cancelled/Not Join allotted a seat in BAMS/BHMS/BUMS (Group B) CAP Round 2 has to Unlock Application and Submit form once again and make payment from candidate login.
- 3. The choices filled by candidates for CAP Round 2 will be treated as null and void. All candidates participating in CAP Round 3 must fill fresh choices (preferences) for this round.
- 4. Candidates must complete registration and upload all the requisite original scanned documents within the stipulated schedule.
- 5. Candidate allotted a seat in AIQ Round-3 of AACCC will not be considered for CAP Round -3 and subsequent round for State counseling.
- 6. It is mandatory to join the allotted seat of CAP Round -3. Candidates who are allotted a seat in CAP Round-3 will not be considered for subsequent rounds irrespective of whether they join or do not join to the allotted seat of CAP Round 3.
- 7. Candidates should also ascertain her/his eligibility for admission to the various courses before filling up the registration form.
- 8. PWD candidates should have claimed the quota at the time of NEET. They should submit Online PWD certificate issued by any one of the 16 boards.
- 9. As per G.R. of General Administration Department ROD-4019/C.R 31/ 16- A, dated 12 February 2019 and Government Resolution no. MED-1018/C.R 37/19/Edu- 2, dated 07th March, 2019. "EWS" means Economically Weaker Section, include persons who are not covered under the scheme of reservation for SC, ST, DT-A, NT-B, NT-C, NT-D, OBC (Inculding SBC) & SEBC.
- 10. Candidates belonging to reservation category must claim so in the application form before submitting the same.
- 11. Any claim for converting from Open/General category to reserved category after submission and payment shall not be entertained.
- 12. NRI candidate should register on <u>Foreign Candidate Registration Portal</u> **before 19/10/2025** for verification of candidate's eligibility. The subsequent schedule will be as above.
- 13. NRI candidates should note that they are eligible only for 15% Institute Quota as per merit.
