# **IMPORTANT NOTE:**

- Tamil Nadu Medical Selection Committee discourages candidates from seeking any Agent/ Agencies help in application and counselling process.
- The candidates and their parents will be solely responsible for all the documents submitted by them.
- Do not rely on Agents/ Touts in the counselling process.
- All candidates must ensure that they have provided the correct email address and mobile number. When candidates register, they have to enter the OTP received on their registered mobile number and the mobile number and email address are essential in every stage of the counselling and admission process.

#### 1. DISCLAIMERS

- a. Qualified and eligible candidates are required to register ONLINE on the Tamil Nadu medical selection committee website <u>https://tnmedicalselection.org</u> to participate in the counselling process for allotment of seat. TN medical selection committee does not allot any seat manually (for all General Category seats).
- b. Candidates are deemed to have read, agreed and accepted this prospectus and the terms and conditions of the counselling mentioned in this prospectus for Tamil Nadu State 2025-2026 UG (MBBS / BDS) Counselling on completing the online submission of application form.
- c. Application for Tamil Nadu State 2025-2026 UG (MBBS / BDS) Counselling can only be submitted online through Medical Counselling Committee website <a href="https://tnmedicalselection.org">https://tnmedicalselection.org</a> Application submitted through any other mode shall not be entertained.
- d. Candidates are further advised to fill the application form on their own on the TN Medical Selection Committee website and not through any agent or third party. If they have any difficulty in filling up the online application forms they can approach the facilitation centres at any one of the nearest Government Medical Colleges / Tamil Nadu Government Dental College and the T.F.C. (Tamil Nadu Facilitation Centre) in each District (where there are no Medical Colleges yet) and utilise the facilities to access and apply online.

- e. A candidate can submit Tamil Nadu State 2025-2026 UG (MBBS/BDS) Management quota application form only once. He / She may apply for Government quota (If willing) separately
- f. All payments including the Security Deposit & Tuition fee will be forfeited if a candidate who has been allotted a seat in the Round 3 or subsequent rounds and does not join the respective institution. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. E.g. in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time).
- g. Candidate may kindly note that registering for Tamil Nadu State 2025-2026 UG (MBBS / BDS) Counselling does not confer any automatic rights to secure an Under Graduate seat. The selection and admission to Under Graduate seats in any medical Institution recognized for running Under Graduate courses are as per the Indian Medical Council Act,

- 1956 is subject to fulfilling the merit, admission criteria, eligibility, and such criteria as may be prescribed by the respective universities, medical institutions, National Medical Council/Dental Council of India and State/Central Government.
- h. Candidate should ensure that all information filled during the online submission of application form are correct and factual. Information provided by the candidates in the online application/registration form shall be treated as correct and self-certified and Tamil Nadu Medical Selection Committee shall not entertain, under any circumstances, any request for change in the information provided by the candidates.
- i. The candidate will be responsible for all the documents submitted by him/her. Any candidate who is found to have produced/submitted any document/certificate which is false/forged/fake at any stage of counselling or admission process or later, will have his/her candidature cancelled and any seat even if allotted/joined will be immediately terminated and necessary legal actions will be initiated against the individual and / or parents. Also, the candidate will not be allowed in the counselling for Tamil Nadu UG medical admissions for the current year (in any category) and also will be debarred from participating in TN UG medical counselling for the subsequent three years. Also, all the fees paid by him/her will be forfeited including Security Deposit and Tuition Fees and such
- j. The information regarding Fee structure/ course Content / bond rendering of service in rural / tribal area/other conditions etc. has been provided by Medical /Dental Colleges. Tamil Nadu Medical Selection Committee takes no responsibility regarding the above information including Fees/ Bond/ Mode of Payment or any typographical error/ data etc. Candidates are advised to visit College website or contact the College Authorities directly for any query regarding above information before filling choices. Choices once locked cannot be modified and any request to Selection Committee regarding tinkering of choices will not be entertained.
- k. Candidates are advised to confirm their eligibility status before registering on the Selection Committee website for Institutional/Minority Quota seats of Minority Institutions/ IRT ward / CMC, Vellore before opting for their seats.
- It is informed that the fees for UG management quota should be in accordance with fees prescribed by the Fee Fixation Committee as mentioned in Clause 19. For any grievance regarding high exorbitant fees, candidates are requested to send their grievance through mail to the following E-Mail id. <a href="mailto:ddugselcom@gmail.com">ddugselcom@gmail.com</a> for reporting to the concerned authorities. But the selection committee will not be responsible for any non-compliance by the concerned colleges.

- m. Candidates are advised to be in touch with the Tamil Nadu Medical Selection Committee website (<a href="https://tnmedicalselection.org">https://tnmedicalselection.org</a>) for Schedule / latest updates / Results / Notices / News & Events pertaining to counselling as Selection Committee will not be individually contacting the candidates for the same.
- n. No communication will be directly sent to the Candidate(s). They are advised to be in touch with the website on regular basis for any updates.
- Candidates are advised to use the same Mobile number used by them during application process for all subsequent events of counselling since OTPs will only be sent to those mobile number.
- Court cases with regard to counselling must be within the jurisdiction of Hon'ble Madras High Court.
- q. All admissions and resignations (if permitted) should be made through online mode only.
   Offline resignation of seats is NOT permitted.
- r. Candidates must download the allotment letter from the Selection Committee website only.
- s. The security amount will be refunded to the account (If eligible) as specified by the candidate in the online application form.
- t. The Security deposit and any other eligible refund will be refunded to the candidates Within 3 months of completion of the entire counselling process (if eligible)
- u. All candidates must ensure that they have provided the correct email address and mobile number. When candidates register, they have to enter the OTP received on their registered mobile number and the mobile number and email address are essential in every stage of the counselling and admission process.

# 2. GLOSSARY OF TERMS:


- State Quota: Refers to seats alloted by the Tamilnadu Medical Selection Committee (85% of Government Colleges and 100% Private college seats other than deemed universities). This inludes GQ,MQ,MINORITY, NRI seats referred below.
- 2. **Selection Committee**: Refers to Tamilnadu Medical Selection Committee which is the selection authority for Tamilnadu Medical/Dental/Paramedical admissions. Selection Committee works under the Directorate of Medical Education, Ministry of Health & Family Welfare, Government of Tamilnadu.


- 3. **Application :** Refers to applying forTamilnadu Medical/Dental Undergraduate courses. Happens after NEET-UG 2024 declaration of results by NTA.
- 4. **Application Fees**: Fees paid for applying to Tamilnadu Medical/Dental UG (MBBS& BDS) courses. This fee of Rs.500/- is non-refundable and SC/SCA/ST candidates are exempted from Application Fee.
- 5. **Registration & Choice locking:** Refers to process of online filling up of the Counselling registration form, Paying the requisite fees, Locking their preferred choices to participate in Tamil Nadu Medical Counselling. Candidates can register for Counselling before the Round 2.
- 6. **Registration Fees**: Fees paid for registering in the counselling process. This fee of Rs.1000/- is non-refundable and will be forfeited if the candidate does not join/resign/discontinue the allotted seat in Round 2.
- 7. **General Category**: Refers to seats allotted to candidates who do not belong to any special category (i.e Persons with Benchmark Disabilities, Eminent Sports Persons, Children of Exservice Men or Special Preferential 7.5% Reservation to Government School Students)
- 8. **Government Quota (GQ)**: Refers to seats alloted by the Tamilnadu Medical Selection Committee under Government Quota. This includes seats in Government Medical Colleges and a proportion of seats in Self-Financing Medical / Dental Colleges (50% or more) under Government Quota.
- Management Quota (MQ): Refers to proportion of seats in Self-Financing Medical / Dental Colleges which are under Management Quota (35% or Less). These seats will have a higher fee structure compared to GQ seats.
- 10. NRI Quota: Refers to proportion of seats in Self-Financing Medical / Dental Colleges which are reserved for NRI candidates (15% of SF college seats). NRI quota seats which remain vacant after exhausting choices from all NRI applicants will be converted to NRI lapsed seats in the Round 3 and will be available for MQ candidates. (Except NRI candidates who have been alotted seats, other MQ candidates can fill their choices for such seats.)
- 11. **Minority Quota**: Refers to the candidate belonging to specific Linguistic / Religious minority community to claim seats under the specific minority quota seats in such minority institutions. Candidates should have submitted relevant documents along with the application form itself. Any claim later will be rejected.
- 12. **Merit/Rank List**: Refers to the State Merit List published by the selection Committee based on the NEET score among the applied candidates.

- 13. Security Deposit: Fees paid at the time of registration for counselling especially if candidate wishes to opt for GQ seats in SF colleges/ MQ/NRI Quota. This has been made necessary to avoid seat blocking. Security Deposit will be refunded if the candidate is not allotted seats in any of the rounds or if the candidate joins the allotted seat. Security deposit will be forfeited if the candidate does not join the allotted course in Round 3 or later rounds or if he/she discontinue the allotted course in any round.
- 14. **Allotment**: Refers to a candidate being allotted a seat based on his choice preferred and on the basis of Merit & Rule of Reservation. Allotment does not confer the rights on the seat unless the candidate pays the prescribed Tuition Fees and downloads the Allotment order within the stipulated time and also joins the instituion within the specified period.
- 15. **Allotment Order:** Refers to the Provisional Allotment Orders issued by the Selection Committee which the candidate downloads from the website after payment of necessary Fees. This order is necessary for joining the allotted institute. Candidate will not be allowed to join the course without genuine allottment order.
- 16. **Tuition Fee:** Tuition fee is fixed by Government of Tamil Nadu / Fee Fixation Committee. This has to be paid via onlline (For MBBS) before downloading the allottement order. Tuition fee does not include other fee (Hostel fee, library fee, mess fee, etc..)
- 17. **Joining**: Refers to the candidate, after downloading the Allotment order reports to the instituition with the original documents and joins the institute. (Round 1 & 2). In Round 3 & Stray round payment of fees and downloading the allotment order itself is considered as Joining. (Considering the absence of Reallotment and Time-Constraints)
- 18. **Resignation**: Refers to the candidate after joining the course, resigning the course for his/her own reasons. This has to be done online only via Selection Committee website and they have to download the resignation form and submit it to the College for them to get back their original certificates.
  - Note: Only in Round 1, resignation constitutes Free exit. In subsequent rounds it is considered as Discontinuation and attracts Forfeiture of Security Deposit and Tuition Fee as well as shall attract Discontinuation Fee.
- 19. Free Exit: Refers to candidate having free choice in quitting/not joining their allotted course in Round 1 before the stipulated date without any adverse condition upon them. This contrasts with provisions like Forfeiture of Fees & Security Deposit or Discontinuation Fee or debarment from participation in counselling which a candidate has to face( as the case may be) if he/she quits or not join the course after the stipulated date in Round 1 or anytime after allottment in subsequent rounds.


- 20. **Forfeiture**: If the candidate does not join the allotted course in Round 3 or later rounds he/she shall forfeit their security deposit and Tuition Fees paid (if any).
- 21. **Discontinuation Fee**: If the candidate discontinues the course after the stipulated date in Round 1 or resigns after joining, any time later, in subsequent rounds he is considered as Discontinued and is liable to pay Discontinuation Fee.
- 22. **Not Joined**: Refers to the candidate who after being allotted has not joined the institution. In round 1 and 2. Not-Joined status offers free exit. But after Round 2 Not-Joined status results in Forfeiture of Security Deposit and tuition fees paid(If any).
  - In Stray rounds or Subsequent rounds (if any) if the candidate downloads allotment order candidate is considered as joined. If after allotted he does not download allotment order he/she is will not be eligible to participate in further rounds of counselling and next academic year counselling in addition to forfeiture of Security Deposit & Tuition Fees(if any)
  - Note: The Fee structure for NRI lapsed seats is different & Higher than that of regular MQ seats.
- 23. **Virtual Vacancy**: Refers to the vacancies which may arise due to reallotment/upgradation of seats in the round 2. Candidates can fill their choices for such seats but they will become real vacancies and be available for allotment only if the candidate who holds such seat and has applied for reallotment / upgradation gets reallotment and vacates such seat.

#### 3. IMPORTANT INFORMATION:

- For periodic updates, the candidates are instructed to remain in touch with the official website www.tnmedicalselection.org frequently from the date of application till the end of admission process.
- 2) The Selection Committee will not be responsible for the consequences resulting due to non-diligent follow-up of notices, notifications and publications appearing on the website regarding counselling and admission to MBBS / BDS Degree Courses 2025-2026 session.
- 3) Rank List will be available on the official website and results will not be communicated individually.
- 4) Any change or modification and relevant information pertaining to this admission process will be made available on the official website.
- 5) The candidates are advised to download the prospectus and read it carefully along with parents / guardian before filling the online application form and ensure that no mandatory column is left blank. In the event of rejection of the application form, no correspondence and request for re-consideration will be entertained.
- 6) The candidates are advised to read the Information Bulletin for NEET-UG 2025 issued by the National Testing Agency (NTA) and carefully go through the instructions regarding NEET-UG 2025 and visit the website www.ntaneet.nic.in regarding detailed qualifying criteria.
- 7) If a candidate is unable to access the online application, then they can appear in person with parent / guardian, with all the original certificates at any one of the nearest Government Medical Colleges / Tamil Nadu Government Dental College and the T.F.C. (Tamil Nadu Facilitation Centre) in each District and utilize the facilities to access and apply online.

8) The online submission of application form for admission to MBBS / BDS Degree Courses 2025-2026 session in Management Quota seats including Minority / NRI in Self-Financing Medical / Dental Colleges affiliated to the Tamil Nadu Dr. M.G.R. Medical University, Guindy, Chennai can be accessed from the following official website:

9) The admissions in the State of Tamil Nadu are as per the provisions of the Government of Tamil Nadu and in compliance to Section 14 of National Medical Commission Act, 2019 and the orders of the Hon'ble Supreme Court of India, the eligibility for admission to MBBS / BDS Degree Courses within the respective categories shall be based solely on marks obtained in the National Eligibility-Cum-Entrance Test (NEET UG – 2025). Candidates who participate in

- MBBS / BDS counselling must qualify NEET Examination in the current academic year 2025-2026.
- 10) As per Clause 6.1.6(a)(ii) of the NEET Information Bulletin 2025 issued by the National Testing Agency, the reservation of the seats in Medical / Dental Colleges for respective categories shall be as per applicable laws prevailing in States / Union Territories.
- 11) The apportionment of seats shared between Government and Management in unaided Self-Financing Medical Colleges and Dental Colleges in Non-Minority Institution is 65:35 and between Government and Minority seats in unaided Self-Financing Medical / Dental Colleges in Minority Institution is 50:50.
- 12) This prospectus is applicable for Management Quota seats including Minority / NRI in Self-Financing Medical / Dental Colleges.
- 13) Christian Medical College seats will be filled as per the Judgement issued by the Supreme Court of India in paragraph 9 of I.A.No.110584/2022 in W.P.(c).No.8/2022 as follows:-
  - 30% seats of Christian Medical College, Vellore will be filled by the State Government following its policy of reservation strictly in accordance with the Government Quota Merit List.
  - For 20% of seats of Christian Medical College, Vellore will be filled from the candidates who are native of Tamil Nadu and belonging to Christian Minority in accordance with the Christian Minority Merit List and candidates who are eligible to claim Christian seats which is a notified minority community as per Section 2 (c) of National Commission for Minorities Act, 1992 should produce a certificate issued by the competent revenue authority of the candidate's native jurisdiction.
  - The remaining 50% of seats are earmarked for admission under CMC Quota for which admissions will be made by the Selection Committee based on the criteria given by the management of CMC, Vellore.
  - 14) At the time of registration, all candidates must pay the Security Deposit of Rs.1,00,000/for Management seats in Self-Financing Medical / Dental College Security Deposit will be
    refunded to the candidates after joining the allotted colleges at the end of all round of
    counselling and to the candidates who have not got any seats during any Round of
    counselling. (Within 2 months of completion of the entire counselling process)
    - Security Deposit will not be refunded for the candidates who have not joined the course in Round 2 or later rounds or who discontinue the course beyond the stipulated date in Round 1 or in later rounds and they will also have to forfeit the Registration fee and tuition fee.

# 4. GENERAL INSTRUCTIONS: -

(a) Candidates seeking admission to MBBS / BDS Degree Courses 2024-2025 session under Management Quota including Minority / NRI Category in Self-Financing Medical/ Dental Colleges affiliated to the Tamil Nadu Dr. M.G.R. Medical University, Guindy and Management Quota including Minority / NRI Category Chennai can access the application form from the following official website:-

- (b) Candidates should submit their filled in online application form after uploading the details in the required fields. The cost of application form of Rs.1000/- (Rupees One Thousand Only) (Non-refundable) should be paid through online payment via Bank payment portal in the website.
- (c) The last date for submission of online application form will be upto 5:00 P.M. on xx-xx-2025. Thereafter there is no provision for the candidates to submit their online application form.
- (d) Candidates should fill up all mandatory columns, upload all required documents and submit the filled in online application. The candidates are instructed to download their filled in online application form and secure a copy of the same for their future reference.
- (e) Candidates should submit the filled in online application after filling up of all fields.
- (f) If seats are vacant in any category after the exhaustion of merit list (From that specific category), those seats will be converted to general category in the subsequent round.

# 5. AGE LIMIT (NEET UG - 2025 Bulletin).

Candidates should have completed 17 years of age at the time of admission or should have completed 17 years on or before 31<sup>st</sup> December of this year 2025

# 6. GENERAL ELIGIBLITY CRITERIA (As per NEET UG - 2025 Bulletin).

- a) Candidates should be Citizen of India.
- b) Overseas Citizen of India(OCI)/Person with Indian Origin (PIO), who are registered under section 7A of Citizenship Act,1955 (Central Act 57 of 1955) are eligible for admission in MBBS/BDS Degree courses subject to the production of proof of such registration. However, OCI/PIO candidates will not be eligible for any kind of reservation and will be

treated only as open category. OCI will be entitled to the rights and privileges which had been conferred on them earlier to the notification dated 04.03.2021. (As per the orders of Hon'ble Supreme Court order, dated 03.02.2023 in W.P No.891 of 2021).

# **Qualifying Criteria:**

The National Testing Agency will prepare an All India Merit List of successful candidates of NEET (UG) – 2025 on the basis of eligibility criteria provided by the Board of Governors in supersession of Medical Council of India and Dental Council of India as given in Graduate Medical Education Regulations 1997 issued under Indian Medical Council Act 1956 and BDS Course Regulations, 2007 issued under the Dentists Act, 1948. The eligibility criteria are as follows:

Admission to MBBS / BDS Degree Courses shall be based solely on marks obtained in the National Eligibility-Cum-Entrance Test (NEET–UG 2025).

- a) In order to be eligible for admission to MBBS / BDS Courses for a particular academic year, it shall be necessary for a candidate to obtain minimum of marks at 50<sup>th</sup> percentile in *National Eligibility-Cum-Entrance Test* to MBBS / BDS Courses held for the said academic year. However, in respect of candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, the minimum marks shall be at 40<sup>th</sup> percentile. In respect of candidates with Bench Mark Disabilities specified under the *Rights of Persons with Disabilities Act, 2016*, the minimum marks shall be at 45<sup>th</sup> percentile for unreserved category candidates and 40<sup>th</sup> percentile for SC / ST / OBC candidates.
- b) Provided when sufficient number of candidates in the respective categories fail to secure minimum marks as prescribed in *National Eligibility-Cum-Entrance Test* held for the academic year for admission to MBBS / BDS Courses, the Government of India in consultation with National Medical Commission and Dental Council of India may at its discretion lower the minimum marks required for admission to MBBS / BDS Courses for candidates belonging to respective categories and marks so lowered by the Government of India shall be applicable for the said academic year only.
- c) To be eligible for admission to the MBBS / BDS Courses, a candidate must have passed in the subjects of Physics, Chemistry, Botany, Zoology / Biology / Biotechnology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry, Biology / Biotechnology at the Qualifying Examination as mentioned in Graduate Medical Education Regulations-1997 as amended in 2018 and BDS Course Regulations, 2007 and in addition must have

come in the merit list of *National-Eligibility-Cum Entrance Test* for admission to MBBS/BDS Courses. In respect of the candidates belonging to the SC, ST and OBC category, the marks obtained in Physics, Chemistry, Biology / Bio-technology taken in qualifying examination and competitive examination (Physics, Chemistry, Biology) must be 40% marks instead of 50%. In respect of candidates with Bench Mark Disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks in qualifying examination in Physics, Chemistry and Biology/Bio-Technology taken together must be 45% instead of 50% for Unreserved category candidates and 40% for SC / ST / OBC candidates.

d) Candidates who have passed 10+2 from Open School or as private candidates shall not be eligible to appear for 'National Eligibility-Cum-Entrance Test'. Furthermore, study of Biology/Biotechnology as an additional subject at 10+2 level also shall not be permissible.

The proviso in italics has been subject matter of challenge before the Hon'ble High Court of Delhi, Hon'ble High Court of Allahabad, Lucknow Bench and Hon'ble High Court of Madhya Pradesh at Jabalpur. The provisions of the regulations disqualifying recognized Open School Board candidates and the candidates who have studied Biology / Biotechnology as an additional subject has been struck down. "The Medical Council of India has preferred Special Leave Petitions before the Hon'ble Supreme Court. Therefore, the candidatures of candidates in the NEET (UG)-2025 who have passed the qualifying examinations i.e. 10+2 from National Institute of Open Schooling or State Open Schools or as private candidates from recognised State Boards; or with Biology / Biotechnology as additional subject shall be allowed but subject to outcome of Special Leave Petitions / Appeals filed by the Medical Council of India".

e) The candidates of other Boards / Universities / Countries (except State Board/CBSE Board/ISCE) who wish to take up a MBBS / BDS seat in the State of Tamil Nadu should submit the Eligibility Certificate obtained from the Tamil Nadu Dr. M.G.R. Medical University, Guindy, Chennai, at the time of online application.

#### 7. ELIGIBILITY FOR MINORITY SEATS:

- i. The candidates who are native of Tamil Nadu with mother tongue Telugu / Malayalam are eligible for Linguistic Minority seats.
- ii. The candidates who are native of Tamil Nadu with Christian Religion are eligible for the Christian Minority seats.

- iii. The candidates who are eligible to claim Linguistic Minority seats reflecting their mother tongue (Telugu / Malayalam) should produce the Study Certificate (including linguistic details) issued by the Head of the Institution last studied (Annexure I (a))
- iv. The candidates who are eligible to claim Religious Minority seats (Christian) which is a notified minority community as per Section 2(c) of National Commission for Minorities Act, 1992 should produce certificate issued by the competent revenue authority of the candidate's native jurisdiction Annexure I (b).
- v. As per the I.A.No.110584/2022 in W.P.(c). No.8/2022, Which reads thus:
  - a) 50% of Christian Medical College, Vellore seats shall be filled up by the Management by the same procedure that was being followed for earlier the academic year's college on the basis of inter se merit as per the NEET results.
  - b) Out of this 50% of Christian Medical College, Vellore Management quota seats, as per past practice 10% seats to be allotted to the children of the staff members working in the applicant college on the basis of inter se merit as per the NEET results.

The Christian Candidates those who wish to opt MBBS Management seats in Christian Medical College, Vellore refer the college website (<a href="www.cmch.vellore.edu">www.cmch.vellore.edu</a>)

#### 8. ELIGIBILITY CRITERIA FOR NRI:

The following guidelines shall be followed for admission to MBBS / BDS Degree Courses 2025-2026 session for NRI category under Management quota in Self-Financing Medical / Dental Colleges in Tamil Nadu:-

a) Candidates should be Indian Origin settled in foreign countries.

OR

Candidates who were born in foreign countries and whose parents are of Indian Origin.

OR

Children of Indian citizen staying abroad for employment, business.

ΟR

Children of Indian citizens deputed abroad by Public Sector Undertaking.

OR

Children of the Official of the Central / State Government on deputation to abroad.

- b) The candidates seeking admission to NRI Quota should hold an Indian passport.
- c) The candidate should have completed 17 years on or before 31st December 2025.
- d) Candidates seeking admission to MBBS/BDS Course under NRI Quota should have passed H.S.C Examination (10+2 pattern) / equivalent.
- e) The candidates should have obtained a minimum of 50% marks in Biology or Botany and Zoology / Bio-technology taken together and the minimum of 50% marks each in Physics and Chemistry.
- f) The medium of Instruction should be English.
- g) In cases where two or more candidates obtained equal marks, rank of such candidate may be determined on the basis of the seniority in age.

- h) Admission under Non-Resident of India scheme may be made on the basis of the marks obtained in the Qualifying Examination in NEET UG-2025.
- i) The seats under NRI quota should be utilized by the Bonafide NRIs only and for their children or wards. Therefore, the NRI financially supporting the candidates should either be the parent (Father of Mother) of the candidate or the spouse or the blood relatives of the candidates or legally declared as guardian of the candidate by the Court as per provisions in "The Guardians and Wards Act, 1890".

# **Blood Relatives:**

Blood Relatives are defined as

- i) Real brother and sister of the candidate.
- ii) Real brother and sister of father i.e. real uncle and real aunt.
- *iii)* Real brother and sister of mother i.e. real maternal uncle and maternal aunt.
- iv) Father and mother of father i.e. grandfather and grandmother.
- v) Father and mother of mother i.e. maternal grandfather and maternal grandmother.
- vi) First degree-paternal and maternal cousins.
- vii) Such person should be NRI.
- j) Candidates applying under "NRI" quota should upload the following documents:-
  - NRI status of the financial supporter issued by the Indian Embassy of the respective country under their seal or OCI card
  - ii. Certificate of Relationship between the NRI financial supporter and the candidate issued by the competent Revenue authority, valid Indian Passport of the NRI financial supporter.
  - iii. NRE (Non Resident External) Bank Account Pass Book of the financial supporter.
- k) Overseas Citizen of India (OCI) Candidates applying for NRI Seats should upload the following documents:
  - i. OCI Card of the Sponsor
  - ii. Candidate's OCI card.
  - iii. Candidate's Birth Certificate.
  - iv. Either One of the Parent's Indian Passport / OCI card and any one of SSLC / PUC / HSC Mark sheet / Transfer Certificate.
  - w. Ward Certificate (Annexure II).
- Candidates who apply under NRI quota are instructed to furnish equivalent marks for the grades awarded at the qualifying examination. If not, the minimum marks will be taken into consideration.

- m) Candidates who apply under NRI quota are instructed to submit their certificates/ documents at the time of submission of filled in online application. If he / she fails to submit the required certificates / documents, his / her application will be summarily rejected under NRI Quota.
- n) As per NEET UG-2025 Information Bulletin Clause 5.2.2., the OCI (including P.I.O.) cardholder shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

# 9. NON-ELIGIBILITY CRITERIA:

- a. If the candidates of other Universities / Boards (except State Board) do not submit the Eligibility Certificate obtained from the Tamil Nadu Dr. M.G.R. Medical University, Guindy, Chennai, then their application will be summarily rejected.
- b. Candidates presently pursuing the MBBS course in Tamil Nadu or in other States of India or other countries are NOT ELIGIBLE to apply for the MBBS Course once again.
- c. Candidates presently pursuing the BDS course in Tamil Nadu or in other States of India or other countries are NOT ELIGIBLE to apply for the BDS Course again.

# 10. PROCEDURE FOR FILLING AND SUBMISSION OF ONLINE APPLICATION FORM:

The candidates are advised to take a print out of the Prospectus from the official website and read it carefully, along with the parent / guardian before filling up of the online application form for the academic year 2025-2026.

The candidate should login to the following website:

The application forms will be available online from xx-xx-2025 to xx-xx-2025 upto 5:00 P.M.

Candidates should submit their filled in online application form after uploading the details in the required fields. The cost of application form of Rs.1000/- (Rupees One Thousand Only) (Non-refundable) should be paid through online payment via Bank payment portal in the website.

I. Candidates have to fill up all the mandatory columns in the online application. All the relevant documents should be uploaded in PDF format. Candidates are instructed to submit the online application after filling up all the required fields.

- II. Request for change in any particulars after submitting the online application form shall not be entertained under any circumstances.
- III. Candidates are instructed to upload the following certificates while filling the online application form and submit:
  - i. NEET- UG 2025 Admit card and Score card.
  - ii. Class X Mark Sheet (both sides of Mark Sheet).
  - iii. Class XI Mark Sheet (both sides of Mark Sheet).
  - iv. H.S.C. Mark sheet (both sides of mark sheet) or any other equivalent examination.
  - v. Transfer certificate obtained after the completion of H.S.C. or equivalent courses.
  - vi. Certificate for proof of study from VI std. to XII std.
  - vii. Candidates who are eligible to claim linguistic minority seats in Self-Financing Medical / Dental Colleges should produce a study certificate issued by the Head of the Institution last studied- Annexure I (a) or to claim religious minority should produce a certificate issued by the competent revenue authority of the candidate's native jurisdiction Annexure–I (b) along with the following certificates:
    - a) Nativity certificate obtained from Tamil Nadu for the candidates who are seeking admission under minority category.
    - b) Permanent Community Certificate Card.

viii. Candidates who are claiming NRI Seats should upload the following documents:

1. NRI status of the financial supporter issued by the Indian Embassy of the respective country under their seal.

- 2. Certificate of Relationship between the NRI financial supporter and the candidate issued by the competent Revenue authority, with valid Indian Passport of the NRI financial supporter.

After submitting filled in online application, the candidates are instructed to download their filled in online application form.

- IV. All the entries in the online application form should be filled by the candidates carefully. The candidate should ensure that all information including the marks in the qualifying examination furnished by him / her in the application and the enclosures are correct. The candidates are informed that after proper scrutiny of his/ her application, the marks furnished by him / her in the application are not correct or any other information is found to be incorrect, then;
  - (a) He / She will forfeit the admission, no matter at what stage of the course, he / she will be at that time;
  - (b) He / She will be debarred from pursuing any other course for a period of three years;
  - (c) Legal proceedings / criminal action will be initiated against the candidate along with their parents for furnishing false Mark Sheet / false Community Certificate / false Nativity Certificate.
- V. Even if the candidate is provisionally selected for the MBBS / BDS admission but found to be failed in +1 examination, the provisional admission of the candidate shall stand automatically cancelled.
- VI. Instructions for filling the Online Application Form:
  - a. The candidate and the parents / guardian must ensure that his / her eligibility criteria before submitting the online application form. The candidates are instructed to go through the Prospectus carefully and be clear about all the instructions with regard to the submission of the online application form.

- b. The application form other than the one filled in online mode will not be accepted, under any circumstances.

- a. Same passport size photograph which was uploaded in NEET UG-2025 examination must be uploaded in the online application form. It should also be pasted in the attendance sheet maintained at the counselling hall and also should be submitted at the time of admission at the allotted Medical / Dental College.
- b. The candidates should upload their signature in running hand writing (4 kb to 20 kb) in the appropriate box given in the online application form. Placing initials as signature is not acceptable. Writing full name in the box in capital letters would also not be accepted as signature and the application form would be rejected.
- c. The candidates must ensure that photograph and signature are uploaded in the respective fields.

- d. The candidate should put his/her left thumb impression on white paper with blue ink and scan for uploading.
- (ii) Incomplete applications without enclosures will be rejected (Educational Certificates, Community Certificate, Photograph, Nativity, Signature etc.)
- (iii) Candidates are advised to submit only one application form.
- (iv) Candidates should ensure that all information entered in the online application are correct during the online submission of application form.
- (v) Incomplete application and applications not in accordance with instruction will not be considered and are liable to be rejected. The application fee once paid will not be refunded.
- (vi) Submission of online application and remittance of fee would close as per the schedule given and no request for extension of time shall be entertained. Application once submitted cannot be withdrawn.

# 11. METHOD OF FEE PAYMENT:

   Necessary facilities have been provided for making payment through nationalized banks via bank payment portal by using Net banking or other modes
- ii. Candidates must note that mere deduction of fee from the Bank account is not a proof of fee payment.
- iii. Check the validity of the Debit card/ Credit card and keep everything ready while logging on to the website for submitting application form. Candidate should enter the information asked for and make payment through the portal.
- iv. The security deposit will be refunded only to the account whose details are provided along with the application form.

If a candidate submits a false / fabricated Community Certificate, Nativity Certificate or any other Certificate, if it is found at a later point during the course of the study, it will result in expulsion of the candidate from the course and also legal proceedings / criminal action will be initiated against the candidate and their parents as per provision of law.

#### 13. RANK LIST: -

Rank List of the candidates shall be prepared on the basis of the marks obtained in National Eligibility-cum-Entrance Test (NEET UG-2025) for MBBS / BDS Degree Courses for the academic year 2025-2026.

# 14. METHOD OF SELECTION AND ADMISSION:

- (i) The admission shall be made on the basis of National Eligibility Cum –Entrance Test NEET-UG 2025 score for MBBS / BDS Degree Courses for the year 2025-2026 for the Management Quota seats including Minority / NRI in Self- Financing Medical / Dental Colleges and Christian Medical College, Vellore affiliated to the Tamil Nadu Dr. M.G.R. Medical University, Guindy, Chennai.
- (ii) Merely appearing and qualifying in NEET (UG) 2025 does not confer any right to the candidate for admission to MBBS / BDS Courses. The selection and admission to MBBS / BDS seats in any Medical Institution recognized for MBBS / BDS Courses is subject to fulfilling the admission criteria, eligibility, rank in merit list, medical fitness and such other criteria as may be prescribed by the National Medical Commission, Government of India, respective State Institutions and Medical / Dental Colleges.
- (iii) Candidate's eligibility for MBBS / BDS Courses is purely provisional and is subject to fulfillment of eligibility criteria as prescribed by the Government of Tamil Nadu as applicable.
- (iv) The Government Orders issued and to be issued from time to time pertaining to any of the matters contained in this prospectus should be read as part and parcel of this Prospectus

- and such terms and conditions in the Government Order are deemed to have been incorporated in this Prospectus.
- (v) Seat sharing with Self-Financing Minority and Non- Minority Medical / Dental Colleges will be as per State Policy and National Medical Commission / Dental Council of India regulations and applicable Court orders.
- (vi) Among seats under Management Quota, 15% total sanctioned seats will be allotted for NRI Quota.
- (vii) Unfilled seats of NRI Quota will be reverted in round 3 and subsequent rounds of counselling.
- (viii) Self-Financing Minority Medical / Dental Colleges, Minority seats will be fill up as per the Linguistic / Religious Minority Rank List.
- (ix) If adequate number of eligible linguistic / Religious Minority candidates are not available under Minority category, then the earmarked seats will be reverted back to Management Quota (General) category and it will be filled as per the Management Quota (General) rank list.

#### 15. ROUNDS OF ONLINE COUNSELLING:

# There are four rounds of Counselling:

- 1. Round 1
- 2. Round 2
- 3. Round 3
- 4. Stray Round

# I. GENERAL COUNSELLING INSTRUCTIONS:

- a) The counselling Schedule will be available in the official Website.
- b) At the time of counselling registration, all candidates must have to pay the Security Deposit of Rs.1,00,000/- via Online Payment Portal for Management Quota including Minority / NRI Category seats in Self-Financing Medical / Dental Colleges.
  - Security Deposit which will be refunded to the candidates after joining the allotted colleges at the end of all Rounds of counselling and if the candidate could not get any seat during all Rounds of counselling.
  - Security Deposit may not be refunded for the candidate who has not joined or discontinued the course after completion of 2<sup>nd</sup> Round of counselling and subsequent Rounds of counselling and they will also have to forfeit the Registration fee and tuition fee.

- The security deposit will be refunded only to the account from where security deposit was initiated and so it is preferable to keep alive bank account for the same.
- c) Candidates are instructed to register and lock their Choice of seats for each rounds of counselling within the stipulated date and time as mentioned in the counselling Schedule.
- d) Once the candidate locks his/her choices during the online counselling, it cannot be changed later.
- e) Admission to MBBS/BDS course shall be made by online counselling on the basis of rank and based on the preference of Choices given by the candidate.
- f) The candidates should produce their ORIGINAL CERTIFICATES in person at the time of joining in their selected Colleges along with the scanned copy of original certificates to the concerned Colleges.
- g) Candidates are advised not to share Login ID, Password and OTP with others.
- h) Mutual transfer/Individual request for transfer of college will NOT be permitted under any circumstances.
- i) Provisionally selected candidates can download the provisional allotment order by paying the tuition fee as mentioned in clause 19.

  Joined candidates upto Round 3 of All India Quota or State Quota shall not be eligible to participate in the further rounds for All India Quota or State Quota from the academic year 2025-2026 onwards as per the directions of the Hon'ble Supreme Court of India vide order dated.31.03.2022 in W.P.(C).No.174 of 2022 and DGHS guidelines issued in Ref. No. U/12021/01/2022–MEC, dt.12.07.2022.

  Further, Medical Counselling Committee of DGHS MoHFW has developed a Software for all the participating States / Counselling Authorities for NEET-UG to upload the name and Roll numbers of students who have joined upto Round-II and further Rounds of the State Quota or Round-II of the All India Quota on the common portal.

# II. ROUND-1 OF ONLINE COUNSELLING:

- I. The candidates should pay a non-refundable amount Rs. 1,000/- (Rupees One thousand only) towards Registration Fee and Security Deposit (Refundable) amount Rs.1, 00, 000/- (Rupees One Lakh Only) via online Bank payment portal via Bank payment portal.
- II. A candidate who has not registered in the Round 1 of online counseling will be permitted to attend round 2 of online counselling.

- III. A candidate who has taken a seat and Not Joined/ Resigned the course within the stipulated time will be eligible to attend the subsequent rounds of online counselling for the academic year 2025-2026.
- IV. Re-allotment is permitted only during the Round 2 and Round 3 of counseling based on rank.
- V. If a candidate fails to join the College within the stipulated time, in the Round 1 of counselling he/she will be permitted to participate in the Round 2 of online counselling.

# VI. ROUND-2 OF COUNSELLING:

- a) Candidates who had registered for Round-1 and did not get any seat allotted are not required to register again. Also, candidates who have not reported in Round-1 need not register again. Candidate who have joined the seats and wish to opt for upgradation need not register again.
- b) Fresh registration is permitted in this Round for those candidates who have not registered in Round-1 (with full payment of fees).
- c) Candidate who wish to retain their seats (who don't want a change in college) need not participate in this Round.
- d) If upgraded in Round 2, the candidate has to relinquish the seat from Round 1 and join Round 2 allotted seat.
- e) Round 2 choice filling will follow the registration and candidates who wish for upgradation, un-allotted candidates and not joined candidates have to fill their choices.
- f) Candidates should be careful while choice filling and it is advisable to choose preferred colleges only.
- g) Candidate could edit their Choice(s) but once the candidate locks their choice(s) during the online counselling, it cannot be changed later.
- h) If the candidate is reallotted in Round 2, then the MBBS / BDS seat allotted to candidates during Round 1 of Counselling will be allotted to other candidates in descending order, not in ascending order.
- I) If the candidate has Not-Joined, candidates can discontinue the course before the stipulated resignation date. These candidates will be eligible to attend the subsequent Rounds of online counselling for the academic year 2025-2026.
- j) If the candidate has joined but Discontinued the course after the stipulated date of resignation he / she will be eligible to attend the Round-3 of online counselling for

- the academic year 2025-2026, but they will have to forfeit the registration fee and Security Deposit paid by him / her.
- k) Candidates who are allotted seats in Round 2 but who don't report or join the allotted institute can participate in further Rounds (without forfeiture).
- Candidates getting upgraded in Round 2 shall NOT have any claim on Round 1 seat.

**Virtual vacancies**: Any candidate who has been allotted a seat in Round 1 and has opted for upgradation in Round 2, that allotted seat of Round 1 will be shown as virtual vacancy in Round 2 and all candidates can fill their choice for the said seat during the choice filling in Round 2. However, such seats will be allotted in Round 2, only if the allotted candidate of Round 1 vacates/upgrades in Round 2 then that virtual vacancy becomes a real vacancy.

# **AVAILABLE SEATS FOR ROUND-2:**

- i. Seats not allotted during Round-1
- ii. Seats vacant due to not joining / resignation by candidate(s) allotted in Round-1.
- iii. Seats available due to up-gradation of candidate(s), who have been allotted and joined during Round-1 (Virtual Vacancy).

# **ELIGIBLE CANDIDATES FOR ROUND-2:**

- iv. Candidates who registered and choice locked in Round-1 but did not get any seat.
- Candidates who have joined at allotted Medical/ Dental College during round-1 of allotment.
- vi. Candidates who have not joined the allotted seats during Round-1.
- vii. Candidates who have joined and resigned their seats in Round-1.

# **NOT ELIGIBLE CANDIDATES FOR ROUND-2:**

- viii. Candidates, who have not registered in Round1 of online counselling.
- ix. Candidates whose names are in the joined list provided by MCC at the end of All India Round -2.

#### VII. ROUND 3 OF ONLINE COUNSELLING:

When a candidate is scheduled to attend the Round 3 online counselling, then the candidate has to pay the Registration Fee of Rs. 1,000/- (non-refundable) via online Bank payment portal. The candidates who have already paid the registration during previous rounds of counselling need not pay again, if they have not been allotted seats.

Downloading of allotment order by the candidate (After payment of Tuition Fee) is considered as joining the college/Seat and the candidate has to report to the institution

within the reporting time. Failure to report will be considered as discontinued and the candidate should pay the Discontinuation Fee as per Clause 20.

# **AVAILABLE SEATS FOR ROUND 3:**

- (a) Non-allotted seats after Round-2 of Counselling.
- (b) Seats vacant due to not joining / discontinuation by candidate(s) allotted after Round-2 of Counselling.

# **ELIGIBLE CANDIDATES FOR ROUND 3:**

- a) Candidates who registered for Round-1 or Round-2 and did not get any seat allotted are not required to register again.
- b) Fresh registration for the round (Already applied Candidates who are in the Merit List) is permitted for this Round those candidates who have not registered in Round-1 or Round-2 (with full payment of fees).
- c) Joined candidates upto Round 3 of All India Quota or State Quota shall not be eligible to participate in the further Rounds for All India Quota or State Quota from this academic year (i.e) 2025-2026 as per information bulletin DGHS.
- d) If upgraded in Round 1 to Round 2, the candidate must get relieved from Round-1 or Round-2 seat and join Round 3 seat.
- e) Once the candidate joins the Round 3 seat, candidates cannot upgrade or resign from this seat.
  - If any candidate does not join the Round 3 allotted seat, candidate will have to forfeit the Registration fee, Security Deposit & Tuition Fee paid by him / her. And they will also be not eligible to participate in the subsequent Rounds of counselling

# **NOT ELIGIBLE CANDIDATES FOR ROUND 3:**


- (c) As per DGHS notification Ref. U-12021/ 01/ 2022 -MEC dated 12.07.2022, a candidate joined under All India Quota or State Quota in the previous rounds will not be allowed to State Quota Round 3 counselling.
- (d) Candidates whose names are in the allotted list provided by MCC at the end of Round 3.
- (e) If a candidate is allotted during State Round 3, he/she will have to join the allotted college. Allotted candidates during Round 3 will not be eligible for subsequent State Stray Vacancy round.


#### V. STRAY ROUND OF COUNSELLING:

- a. Stray Round of Counselling will be conducted by the Selection Committee as per the directions of the Hon'ble Supreme court in in its order dated 12.12.2022 and also as per the guidelines of MCC/DGHS.
- b. The candidates should pay an additional Security Deposit amount Rs.5 Lakhs (Rupees Five Lakhs only) for MBBS Course and 2 Lakhs (Rupees Two Lakhs only) for BDS Course for participating in the Stray Round or subsequent Rounds (If any) via online Bank payment portal, which is not refundable, in case the candidate after allotment does not join the course. This arrangement is done to avoid precious UG Medical / Dental seats remaining vacant at the end of multiple Rounds of counselling.
- c. Candidates who are not holding any seats in MBBS/BDS course will be eligible to participate in this Counselling.
- d. Candidates who have joined in All India and State Quota seats for MBBS/BDS will not be eligible to participate in this Counselling.
- e. Downloading of allotment order by the candidate (After payment of Tuition Fee) is considered as joining the college/Seat and the candidate has to report to the institution within the reporting time. Failure to report will be considered as discontinued and the candidate should pay the Discontinuation Fee as per Clause 20.
- f. Allotted candidates during Stray vacancy Round, if they fail to join or discontinue the course, they will have to forfeit the Security Deposit and Tuition Fee in addition to payment of Discontinuation Fee. They also will not be able to participate in TN UG Medical Counselling for subsequent one academic year.
  - VI. i) If it is found that a candidate has involved in impersonation / suppression or misrepresentation of facts and production of falsified / bogus certificates by the candidates, his / her provisional allotment order will be cancelled and legal proceedings / criminal action will be initiated.
    - (ii) If during the NEET 2025 or at any stage of allotment/ admission process of Medical/ Dental Admission In Tamil Nadu 2025-2026 or in the admission process of Medical/ Dental Admission In Tamil Nadu 2025-2026 at the allotted College have indulged in any case of impersonation i.e. not matching the photograph/signature/ documents of the candidates etc., he/she shall be handed over to the Police by the Dean / Principal / The Director of Medical Education as the case may be and the cases shall be dealt as per the Indian Penal Code in

- this matter for further investigation. Such candidates will be debarred permanently from appearing for the Medical / Dental Admission in Tamil Nadu in future in addition to the cancellation of his/her candidature in the Medical / Dental Admission in Tamil Nadu of the year.
- (iii) The Selection Committee will not be responsible for approvals obtained/annual renewals and other applicable statutory approvals of various authorities including National Medical Commission / Dental Council of India, infrastructure and the rules and regulations of the Self-Financing Private Medical / Dental Colleges. Hence, candidates are advised to go through the respective college websites and satisfy themselves before giving their option for selection of such seats by the candidates. The Selection Committee shall neither be responsible nor shall entertain any case on the above grounds.
- (iv) MBBS / BDS Seats in Government / Self-Financing Medical / Dental Colleges are subject to routine renewal and approval of the National Medical Commission / Dental Council of India. Therefore, allotment will be made to the Colleges for which National Medical Commission / Dental Council of India / Government of India / Government of Tamil Nadu / The Tamil Nadu Dr. M.G.R. Medical University permission is available on the date of counselling. Allotment will also be made for the newly sanctioned colleges, if any, within the cut-off date.
- (v) Seat matrix for Government Medical and Dental Colleges and Government Quota seats in Self-Financing Medical / Dental Colleges will be released in the website before online counselling and any addition of Colleges / Seats will be displayed at the time of online counselling.
- (vi) Any existing / new college getting recognition from the National Medical Commission/ Dental Council of India will be included at the time of online counselling.




#### 16. COUNSELLING PROCEDURE:

The selection will be made based on NEET – UG 2025 score and by counselling through Single Window System.

- a) Counselling Schedule will be available on the official website.
- b) Candidates should participate in the counselling session as per their rank and schedule.
- c) Candidates are instructed to visit the official website frequently for updates: www.tnmedicalselection.org
- d) Candidates can choose a course at any college and exercise their option as per their eligibility norms mentioned in this Prospectus.
- e) Rules will apply as applicable for the Management quota seats as per the prevalent National Medical Commission / Dental Council of India, rules and regulations, State Policy, the relevant rules of Institutions applicable to the Management quota seats of Self-Financing Medical / Dental Institutions and the orders of the Hon'ble Court wherever applicable.
- f) A Candidate who is absent during the 1st Round of counselling will not be permitted to attend the second Round of Counselling.
- g) Any individual intimation will not be sent to the candidates regarding counselling. The candidates are therefore advised to check the official website frequently till the end of counselling.
- h) Option once given during counselling cannot be changed during the same Round of counselling.
- i) Mutual transfer / Individual request for transfer to a College/Course will not be permitted under any circumstances.

(b) Selected candidates have to pay entire Tuition fee, etc., at the time of downloading the allotment order through online via RTGS / **NEFT** Check the validity of the Debit card and bank balance while logging on to the website while making payment online. Candidate should enter the information asked for and make payment through online.

Any grievances regarding collection of fees by the Self Financing Institutions have to be represented only to the "COMMITTEE ON FIXATION OF FEES IN RESPECT OF SELF-FINANCING PROFESSIONAL COLLEGES".

- (c) Detailed information regarding Scholarship, Fee Concession, Hostel Facilities, Transport, Mess charges, etc., can be obtained from the Head of the Institution in which the candidate joins.
  - After receipt of the joining report from the Deans of the respective colleges, the Tuition Fee amount will be transferred to the concerned colleges.
- ii. The admission to MBBS / BDS Degree Courses for 2025-2026 will close on the cut-off date of admission (i.e. on xx. xx. xxxx) as per the guidelines issued by the Medical Council of India / Dental Council of India.

#### 20. DISCONTINUATION FEE:

- ➤ The candidates who discontinue the course after the cut-off date should pay the Discontinuation Fee of **Rs.10,00,000/-** by means of Demand Draft drawn in favour of "The Secretary, Selection Committee, Kilpauk, Chennai-10" payable at Chennai.
- ➤ If a candidate selects a seat in final stray round of counselling and does not join the course within the stipulated time, then the candidate has to pay the Discontinuation Fee by means of Demand Draft drawn in favour of "The Secretary, Selection Committee, Kilpauk, Chennai-10" payable at Chennai and has to forfeit the Security Deposit &Tuition fee.
- ➤ The admission to MBBS / BDS Degree Courses for 2025-2026 will close on the cut-off date of admission as per the guidelines issued by the National Medical Commission / Dental Council of India.
- ➤ The Selected candidates should produce all the original documents at the time of admission to the Deans / Principals of the concerned Medical / Dental Colleges. Selection will be cancelled if the candidates do not produce the original documents at the time of admission.

#### 21. Discontinuation after admission

(i) The candidates who discontinue the course beyond the end of counselling on the year of admission and on any date in subsequent years should pay a sum of Rs.10,00,000/- (Rupees Ten Lakh only) as discontinuation Fee as mentioned in the clause 20.

- ii) The candidates selected for admission and his / her parent / guardian will have to sign the discipline declaration form in Annexure VII. Failure to sign the declaration will result in the cancellation of selection.
- iii) After the cut-off date for admission, as per the guidelines issued by the National Medical Commission / Dental Council of India / Directorate General of Health Services, admission / re-allotment will not be made.
- iv) All selections and admissions for MBBS / BDS Course are only provisional. The selection and admission is liable to be cancelled at any time as and when the eligibility conditions are found to be defective or incorrect or there has been suppression or misrepresentation of facts. The Selection Committee reserves the right of allotment of MBBS / BDS seats.

#### 22. HEPATITIS -B-VACCINATION: -

All Candidates selected for admission to first year M.B.B.S / B.D.S Degree Courses should take the Hepatitis – B - Vaccine before admission and produce a certificate as in Annexure - V.

#### 23. RAGGING:-

- (a) The candidates who join MBBS / BDS Degree Courses should not indulge in any kind of agitation / strike / ragging activity inside / outside the college campus during the course of study. Candidates found to take part in any such activities mentioned above will be expelled from the course / college at any part of the course of study and legal proceedings / criminal action will be initiated against them.
- (b) The extract of letter / direction from MCI as per Letter No.MCI-34(1)2014-Med (Rag.)/ 130894, dated 11.09.2014 is given in Annexure-VI for information of candidates.
- (c) The candidates applying for admission to MBBS / BDS Degree Courses 2025-2026 session under Management Quota / NRI Category in Self-Financing Medical / Dental Colleges are deemed to have read the contents in this Prospectus and agree with all the conditions and clauses and will not have the right to challenge any of the Regulations.

#### 24. FAQs REGARDING COUNSELLING PROCESS:-

Q.No.1: How to apply for UG (MBBS / BDS) Medical admissions in Tamil Nadu?

Ans: After the NEET-UG 2025 results are out, there will be notification in the websites (tnhealth.org & tnmedicalselection.org) for application to UG medical admissions in Tamil Nadu. Candidates are advised to login using their Mobile No (For OTP) and creating

unique User ID and Password. Candidates are advised to read this prospectus carefully and apply through the website in Online mode only.

Note: Cost of applying online: Rs.1000/-

Q.No. 2: I have applied online. Is this enough for getting a seat?

Ans: No. Applying online is just the first stage in the entire process. Once all the applications are received and scrutinized Eligible Merit List of Candidates (Candidates who have applied and are found eligible) will be published in the websites. After this Candidates have to register for the counselling process as mentioned in the scheme of counselling.

Q. No. 3: How do I register for the counselling?

Ans.: After the Merit List is published candidates have to register before the onset of counselling by paying the non-refundable registration Fee of Rs.1000/- in the website after logging in using the same credentials (User ID, Password, Mobile No) used during the application process. Registration is allowed before Round 1, Round 3 and Stray Round and Fresh registration is not allowed before Round 2 (as this is a re-allottment round)

Note: Registration is allowed only for already applied candidates who are in the Eligible Merit list and not for those candidates who have not at all applied to Tamil Nadu Medical Selection.

Q. No. 4: How and when I had to make the payment?

Ans: After logging for fresh registration, payment page appears automatically. Candidate can do online payment by Net Banking / credit card / debit card only after the successful payment candidate can proceed for choice filling.

Q.No. 5: How do I fill the Choice filling form on website?

Ans: Candidates will have to log on to website <a href="https://tnmedicalselection.org">https://tnmedicalselection.org</a> to get registered and then fill in choices. Please study counselling scheme carefully. It is advised that after going through the list of seats available, a tentative list may be prepared first as per your preference of colleges, before attempting to fill choices on-line. Candidates are advised to read and understand the prospectus completely before filling their choices.

Q. No. 6: Is there any restriction for filling up number of choices of Institution (College) (and courses i.e. MBBS or BDS) in choice filling form?

Ans: No, you can give as many choices as you wish during online choice filling. However, choices should be in order of candidates' preference. There will be common software for Government Quota / Management Quota / NRI Quota / Minority Quota / NRI Lapsed seats for filling up choices. The choices will be available based on your eligibility and application.

For example: A Telugu Minority candidate who has applied for Management quota will be shown TM MQ seats but the same seat will not be available for General MQ applied candidate and also If a Telugu Minority candidate has not applied for Management Quota he will not be shown TM MQ or other MQ seats at all.

Q. No.7: Is it necessary to fill up the choices and lock the choices to get seat allotted? Or I will be allotted seat automatically from leftover seats?

Ans: After online registration (registration is compulsory to take part in online allotment process, before the round s during specified registration period), you have to fill in choice of Institutions/colleges/courses in order of your preference. Once choice is filled in, it can be modified before locking it. If candidate does not lock the choice submitted by him/her, it will be automatically locked as per schedule.

Note: If the candidate does not fill choices for any college, he/she will not be allotted any seat during the counselling

#### **IMPORTANT:**

Don't wait till the last minute to Register and Lock your choices. Please go through your submitted choices before locking, as once you lock the choices they cannot be modified or changed even if you have made a mistake. It may result in allotment of a seat which you never wanted. (Please note that the choices once locked cannot be unlocked even from the Selection Committee)

Q. No. 8: Is it necessary to join allotted Medical/Dental College of Round 1 to get chance to participate in Round 2?

Ans: No, candidates need not report or join the allotted college of Round 1 since there is free exit.

However, if they want to retain the Round 1 seat and upgrade in round 2 they have to physically join the college of Round 1 and participate in Round 2 online.

Q. No. 9: Can a candidate participate in Round 2 without submitting fresh choices (based on choices submitted before round-1)?

Ans: Fresh choice submission by eligible candidates, as mentioned above is necessary for consideration for seat allotment during any round. If candidate does not submit fresh choice(s) during choice filling period, the candidate will not be considered for allotment of seat during Round- 2 and will retain the already joined seat, if any.

- Q. No.10: If a candidate does not report at the allotted college during Round 2 whether he has to register again for Round 3?
- Ans: Yes, the security Deposit and Registration Fee will be forfeited and he has to register fresh in Round 3 with Fresh Payment.
- Q. No.11: If I opt to participate in second round of counselling whether my allotted seat (of first round) will be cancelled?
- Ans: In case you are not allotted any seat in the second round, you will retain earlier allotted seat in Round 1 if you had joined already. However, on up-gradation of a seat in second round, the earlier allotted seat in Round 1 will automatically be cancelled and allotted to another candidate. Therefore, you are advised to fill in only choices which you prefer over the earlier allotted seat, for second round.
- Q. No.12: After I join Second Round of Counselling of AIQ can I leave/ Resign to join State Quota seat?
- Ans: Once you join second round seat, you will not be allowed to vacate from allotted 2nd round seat as per direction by Hon'ble Supreme Court in WP(C) (267/2017) dated 09/05/2017.

However, if you are allotted a seat in Second Round and have not joined the college/institute you can Exit with Forfeiture of security deposit and Tuition Fee. Vide Order dated 22/07/2022 in Contempt Petition No. 289 of 2022 before the Hon'ble Supreme Court of India it has been approved that MCC of DGHS has developed a software for all participating states and counselling authorities for the NEET-UG/PG in order to ensure that the names and roll numbers of candidates who have joined up to round 2 and further rounds of the state quota or round 2 of AIQ are put up on the common portal. Moreover, the candidates who have joined up to round 2 of AIQ or State quota shall not be eligible to participate in the further rounds of AIQ or state quota from the academic year 2022-23. Furthermore, it has been directed by the Hon'ble Court that:

"The development of the above software should ensure that a uniform pattern is followed by all the States across India commencing from the academic year 2022- 2023.

... "all the States and counselling authorities in the NEET- UG/PG shall scrupulously comply with the above directions from the academic year 2022-2023."

Therefore, not joined candidates in Round 2 of AIQ or SQ will be allowed exit with forfeiture and allowed to participate in further counselling process for 2024-2025 whereas Joined candidates will not be allowed to participate in further counselling for the year.

- Q. No. 13: What is the procedure for Round 3 Counselling which will be conducted by Tamil Nadu Medical Selection Committee?
- Ans. The net vacant seats due to Not allotted/non joining, non reporting of Round 2 and any converted seats due to lack of candidates in the particular quota will be published in the seat matrix and eligible candidates have to submit fresh choices and the result will be processed as per Choice & Merit applying the rule of Reservation.
- Q. No. 14: Whether Up-gradation is allowed from 2<sup>nd</sup> round counselling of AIQ / State Quota to Round 3 counselling of State/AIQ quota?
- Ans. No, Up-gradation is not allowed once a candidate joins a seat allotted in Round 2 of AIQ or State Quota and the candidate will not be allowed to vacate the seat. The candidate will not be allowed in any further counselling including Stray Vacancy Round.
- Q. No. 15: How much time will I be given to join the allotted college?

Ans: Candidates allotted seats will be required to join the allotted college/course within stipulated time which is mentioned in counselling schedule. However, candidates are advised to join as early as possible and not to wait for last day of joining, due to different schedule of holiday (including local holidays) / working hours in various Medical / Dental Colleges. Therefore, candidates are advised to contact allotted college immediately after declaration of result of counselling allotment process, to know the details. If candidate fails to join the allotted Medical/Dental College within stipulated time, then the allotted seat will be cancelled. For Round 3 and Stray round as there is very little time for the entire counselling process and there is no process of reallotment/resignation, downloading of allotment order after payment of Tuition Fees will be considered as Joined, But the candidate have to report to the allotted college within the stipulated time. If the candidate does not report he/she will be treated as Discontinued and his seat will be considered vacant and he/she will have to pay the discontinuation fee as mentioned in clause 20 in addition to forfeiture of security deposit and Tuition Fees.

Please note that under no circumstances date of joining/date of reporting can be extended by the Selection Committee.

- Q. No. 16: What documents are required at the time of Joining/ Reporting in allotted Medical / Dental / College?
- Ans: Original documents (along with attested photocopies of documents) for admission to under- graduate medical/dental/nursing courses for admission to allotted college are required at the time of joining in allotted Medical / Dental College are as mentioned below:-

- i. NEET- UG 2025 Admit card and Score card.
- ii. Class X Mark Sheet (both sides of Mark Sheet).
- iii. Class XI Mark Sheet (both sides of Mark Sheet).
- iv. H.S.C. Mark sheet (both sides of mark sheet) or any other equivalent examination.
- v. Transfer certificate obtained after the completion of H.S.C. or equivalent courses.
- vi. Certificate for proof of study from VI STD. to XII STD.
- Q. No. 17: What are the various fees to be paid during the counselling process?
- Ans: During registration for counselling students have to pay two different kind of fees for all students Non Refundable Registration fee: -Rs.1000/-

Management and NRI Quota Seats in Self-Financing Medical / Dental Colleges - Rs.1,00,000/-

Tuition Fees: All candidates who are allotted seats have to pay the Tuition Fees (As mentioned in clause 19) online to download the allotment order.

- Q. No. 18: In case candidate had to apply for both Govt. quota in SF Colleges and for management quota should the candidate pay the fee for both?
- Ans. Yes. As per the policy, the candidate has to pay both the fees. In this case the candidate will have to pay fee for GQ in SF Colleges. Rs. 30000/- plus for MQ Rs. 1,00,000/- as security deposit in addition to the registration Fees Rs.1000/-.
- Q. No. 19: What does exit with forfeiture mean in 2<sup>nd</sup> round?
- Ans: Exit with forfeiture means if a candidate is allotted a seat in 2<sup>nd</sup> round and does not want to join the allotted seat he can still exit with forfeiture (losing security deposit) and once candidate has joined the allotted seat he/she would not be eligible for resigning of joined seat.
- Q. No.20: When and where this Security Deposit will be refunded?

#### Ans:

- Security amount will be refunded only after the completion of all rounds of Counselling.
   Selection Committee will notify about the completion counselling on their portal. The Refund Process will be completed within 90 days of such notification.
- 2. The security amount will be refunded to the account which was specifically mentioned by the candidates in the application form.

Hence, the candidate must keep the said bank account ACTIVE till the refund process is completed. If bank account is closed before the completion of refund, the bankers will not be able to complete the refund process. The bankers will take long time to identify & return the failed refunds to Selection Committee and lot of legal formalities are to be complied for initiating refund to a different bank account. Hence the refund to new bank account will take very long time. Neither Selection Committee nor the Banks will be responsible for such delay.

Q.No.21: Do I have to request the Selection Committee to refund the security amount? What is the schedule for refund of security amount?

Ans: No. Candidate need not approach the Selection Committee for refund of security amount. The Selection Committee will publish the list of candidates who are eligible for the refund of security amount on their portal "https://tnmedicalselection.org" once all rounds of counselling are completed. The Selection Committee will initiate the refund of security amount within 45 days and complete the refund of security deposit within 90 days of publishing the eligible list in the Web Portal.

The refund will be credited, depending upon the level of digitalization of candidate's bank, to the candidates account between 2 to 15 days from the date of refund by the Selection Committee.

Q. No.22: Will the Selection Committee bear the bank charges incurred by the candidate while registering for counselling?

Ans: No. Bank Charges if any, incurred by the candidate should be borne by the candidate only.

Q. No.23: Will the Selection Committee pay interest on the refundable security deposit?

Ans: No. The Selection Committee will not pay interest on the refundable security deposit.

Q. No. 24: If I forget my password that I have created during the process of registration, how to retrieve it?

Ans: To retrieve the forgotten password, system facilitates the following process:

The candidate is required to enter the information that he/she filled at the time of registration and then security question & answer thereon to be entered as given during New Candidate registration process. The above data submitted by candidate will be validated with the registered candidate's database. If the above entries match, then only the candidate would be permitted to enter new password to proceed further.

Q. No. 25: Difficulty in login, what may be the problem(s)?

Ans: Please read user manual for the candidates. Follow the instructions about use of browser, use of same spellings. The internet connection should be uninterrupted. In such case, please try to login from other computer having uninterrupted internet connection from which other candidate(s) has logged in successfully.

Q No. 26: I have difficulty in creating Password, what may be the problem(s)?

Ans: Creation of password should be as per password policy. Please follow the password policy. Please use the internet browser as suggested in user manual, as it is difficult to login from some of the other browsers. While creating password avoid using Caps Lock key, instead of Caps Lock key, use shift key.

Q. No. 27: When I try to login for choice filling/ submission, it says wrong password, what may be the problem(s)?

Ans: This can happen if password typed is incorrect. Password is case sensitive, therefore use password which was created by user exactly same as typed while creating. In case password is forgotten, try to retrieve password by using security question and its answer.

#### **IMPORTANT:**

Please keep the information same as that you have furnished on the application form confidential, and do not share the password and OTP with anybody as to register for online allotment process and submit choice you need that information. If somebody else uses that information, he/she can misuse your online registration and prevent you from taking part in online allotment process. Keep print out of application form ready for reference with you.

WHEREAS the candidate has, on his/her application been selected to undergo training for the M.B.B.S/B.D.S Degree Course in the Self Financing Medical/Dental College (hereinafter referred to as the said College).
AND WHEREAS the candidate has agreed to complete his/her training for the said course, at the said College, subject to the condition hereinafter appearing.
Now THEREFORE, this agreement witnesses and it is hereby agreed as follows :
(1) The candidate shall diligently complete his/her training for the said course at the said College, shall abide by the rules of the said College for the time being in force regulating the conduct of students at the said College and shall pass all the examinations prescribed for the said Course by the University or the Medical Institution concerned.
(2) Upon passing the final M.B.B.S./ B.D.S Examination the candidate shall serve as 'Intern' for the prescribed period as laid down by the Medical Council Act, 1956 (Central Act 102 of 1956) and Dental Council Act.
(3) (i) The candidate shall, on demand made by the Government within two years from the date on which he/she registers himself/herself as a Medical Practitioner, serve for a period of not less than five years and in such rural areas as the Government may by General or Special orders specify.
(ii) Those candidates who fail to comply with clause 3 (i) shall have to pay a sum of Rs. 5,00,000/- (Rupees Five Lakhs only) or as the Government may direct as penalty for having breached the contract in the bond.
(4) During the period of Internship under clause (2) and while in service under clause (3) the candidate shall faithfully, diligently and with skill and ability perform his/her duties and observe the rules for the time being in force made by the Governor or the President as the case may be for

(5) While in service under clause (3) the pay and allowances and other conditions of service of the candidate shall be regulated by the rules and orders of the Government for the time being in

regulating the conduct of Government Servants.

# ANNEXURE - VI MEDICAL COUNCIL OF INDIA NOTIFICATION

### New Delhi, the 3rd August, 2009 No. MCI-34(1)/2009-Med./25453

Implementation of the Regulations framed by the Medical Council of India to curb the menace of ragging in medical colleges.

The operative part of the regulation is reproduced as under with regard to curb the menace of ragging in medical colleges:-

- "5. Measures for prohibition of ragging:-
- 5.1 The Medical College/Institution / University shall strictly observe the provisions of the Act of the Central Government and the State Governments, if any, or if enacted and / or for the time being in force, considering ragging as a cognizable offence under the law at par with rape and other atrocities against women and ill-treatment of persons belonging to the SC/ST and prohibiting ragging in all its forms in all institutions.
- 5.2 Ragging in all its forms shall be totally banned in the entire Medical College/Institution / University including its departments, constituent units, all its premises (academic, residential, sports, canteen, etc) whether located within the campus or outside and in all means of transportation of students whether public or private.
- 5.3 The Medical College/Institution / University shall take strict action against those found guilty of ragging and/or of abetting ragging.
- 6. Measures for prevention of ragging at the institution level:-
- 6.1 Before admissions:-
- 6.1.1 The advertisement for admissions shall clearly mention that ragging is totally banned / prohibited in the Medical College/Institution and anyone found guilty of ragging and/or abetting ragging is liable to be punished appropriately.
- 6.1.2 The brochure of admission/instruction booklet for candidates shall print in block letters these Regulations in full (including Annexures).
- 6.1.3 The "Prospectus" and other admission related documents shall incorporate all directions of the Hon'ble Supreme Court and /or the Central or State Governments as applicable, so that the candidates and their parents/ guardians are sensitized in respect of the prohibition and consequences of ragging.
- 6.1.4 A Brochure or booklet/leaflet shall be distributed to each student at the beginning of each academic session for obtaining undertaking not to indulge or abet ragging and shall contain the blueprint of prevention and methods of redress.
- 6.1.5 The application form shall also contain a printed undertaking, preferably both in English/Hindi and in one of the regional languages known to the institution and the parent/ guardian (English version given in Annexure I, Part II), to be signed by the parent / guardian of the applicant to the effect that he/ she is

also aware of the law in this regard and agrees to abide by the punishment meted out to his/ her ward in case the latter is found guilty of ragging and/or abetting ragging.

A database shall be created out of affidavits affirmed by each student and his/her parents/guardians stored electronically, and shall contain the details of each student. The database shall also function as a record of ragging complaints received.

- 6.1.6 The application for admission shall be accompanied by a document in the form of the School Leaving Certificate/transfer certificate/migration certificate/ Character Certificate which shall include a report on the behavioral pattern of the applicant, so that the institution can thereafter keep intense watch upon a student who has a negative entry in this regard.
- 6.1.7 A student seeking admission to the hostel shall have to submit additional undertaking in the form of Annexure I (both Parts) along with his/ her application for hostel accommodation.
- 6.1.8 At the commencement of the academic session the Head of the Institution shall convene and address a meeting of various functionaries/agencies, like Wardens, representatives of students, parents/guardians, faculty, district administration including police, to discuss the measures to be taken to prevent ragging in the Institution and steps to be taken to identify the offenders and punish them suitably.
- 6.1.9 To make the community at large and the students in particular aware of the dehumanizing effect of ragging, and the approach of the institution towards those indulging in ragging, big posters (preferably multicoloured with different colours for the provisions of law, punishments, etc.) shall be prominently displayed on all Notice Boards of all departments, hostels 4 and other buildings as well as at vulnerable places. Some of such posters shall be of permanent nature in certain vulnerable places.
- 6.1.10 Apart from placing posters mentioned in sub-clause 6.1.9 above at strategic places, the Medical College/Institution shall undertake measures for extensive publicity against ragging by means of audiovisual aids, by holding counselling sessions, workshops, painting and design competitions among students and other methods as it deems fit.
- 6.1.11 The Medical College/Institution/University shall request the media to give adequate publicity to the law prohibiting ragging and the negative aspects of ragging and the institution's resolve to ban ragging and punish those found guilty without fear or favour.
- 6.1.12 The Medical College/Institution/University shall identify, properly illuminate and man all vulnerable locations.
- 6.1.13 The Medical College/Institution/University shall tighten security in its premises, especially at the vulnerable places. If necessary, intense policing shall be resorted to at such points at odd hours during the early months of the academic session.
- 6.1.14 The Medical College/Institution/University shall utilize the vacation period before the start of the new academic year to launch wide publicity campaign against ragging through posters, leaflets. seminars, street plays, etc.
- 6.1.15 The faculties/ departments/ units of the Medical College/Institution /University shall have induction arrangements (including those which anticipate, identify and plan to meet any special needs of

any specific section of students) in place well in advance of the beginning of the academic year with a clear sense of the main aims and objectives of the induction process.

The Principal or Head of the Institution/Department shall obtain an undertaking from every employee of the institution including teaching and non-teaching members of staff, contract labour employed in the premises either for running canteen or as watch and ward staff or for cleaning or maintenance of the buildings/lawns etc. that he/she would report promptly any case of ragging which comes to his/her notice. A provision shall be made in the service rules for issuing certificates of appreciation to such members of the staff who report ragging which will form port of their service record.

#### 6.2. On admission:-

6.2.1 Every fresher admitted to the Medical College/Institution/University shall be given a printed leaflet detailing when and to whom he/she has to turn to for help and guidance for various purposes (including Wardens, Head of the institution, members of the anti-ragging committees, relevant district and police authorities), addresses and telephone numbers of such persons/authorities, etc., so that the fresher need not look up to the seniors for help in such matters and get indebted to them and start doing things, right or wrong, at their behest. Such a step will reduce the freshers" dependence on their seniors.

Every institution should engage or seek the assistance of professional counsellors at the time of admissions to counsel 'freshers' in order to prepare them for the life ahead, particularly for adjusting to the life in hostels.

- 6.2.2 The Medical College/Institution/University through the leaflet mentioned above shall explain to the new entrants the arrangements for their induction and orientation which promote efficient and effective means of integrating them fully as students.
- 6.2.3 The leaflet mentioned above shall also inform the fresher's about their rights as bonafide students of the institution and clearly instructing them that they should desist from doing anything against their will even if ordered by the seniors, and that they have nothing to fear as the institution cares for them and shall not tolerate any atrocities against them.
- 6.2.4 The leaflet mentioned above shall contain a calendar of events and activities laid down by the institution to facilitate and complement familiarization of fresher's with the academic environment of the institution.
- 6.2.5 The Medical College/Institution/University shall also organize joint sensitization programmes of 'freshers' and seniors.

On the arrival of senior students after the first week or after the second week as the case may be, further orientation programmes must be scheduled as follows (i) joint sensitization programme and counselling of both 'freshers' and senior by a Professional counselor; (ii) joint orientation programme of 'freshers' and seniors to be addressed by the

principal/Head of the institution, and the anti -ragging committee; (iii) organization on a large scale of cultural, sports and other activities to provide a platform for the 'freshers' and seniors to interact in the presence of faculty members; (iv) in the hostel, the warden should address all students; may request two

junior colleagues from the college faculty to assist the warden by becoming resident tutors for a temporary duration.

- 6.2.6 Freshers shall be encouraged to report incidents of ragging, either as victims, or even as witnesses.
- 6.3. At the end of the academic year:-
- 6.3.1 At the end of every academic year the Dean/Principal/Director shall send a letter to the parents/guardians of the students who are completing the first year informing them about the law regarding ragging and the punishments, and appealing to them to impress upon their wards to desist from indulging in ragging when they come back at the beginning of the next academic session.
- 6.3.2 At the end of every academic year the Medical College/Institution /University shall form a "Mentoring Cell" consisting of Mentors for the succeeding academic year. There shall be as many levels or tiers of Mentors as the number of batches in the institution, at the rate of 1 Mentor for 6 freshers and 1 Mentor of a higher level for 6 Mentors of the lower level.

Each batch of freshers should be divided into small groups and each such group shall be assigned to a member of the staff. Such staff member should interact individually with, each member of the group on a daily 6 basis for ascertaining the problems/difficulties if any faced by the fresher in the institution and extending necessary help.

In the case of freshers admitted to a hostel it shall be the responsibility of the teacher in charge of the group to coordinate with the warden of the hostel and to make surprise visits to the rooms in the hostel where the members of the group are lodged.
