**Educational Notification Regarding
Tripura State NEET PG 2024 Counselling**

The **Last and Final Online Registration and Application** for participation in Tripura State NEET PG 2024 Counselling will be up to **13-01-2025, 12:00 Noon**.

All the eligible candidates who want to participate in Round-3 and/or onwards counselling(if any) of Tripura State NEET PG 2024 Counselling must **apply through online counselling portal(<https://dmeonline.tripura.gov.in/>)** within **13-01-2025, 12:00 Noon**.

This will be the Last and Final option for online registration for the Tripura NEET PG 2024 Counselling for the academic session 2024-25. So, the candidates who will NOT Register and fill the online form by clicking “Apply Now” button through counselling website in this Round-3, he/she will NOT be eligible for any further round(s) in the Tripura NEET PG 2024 counselling.

The candidates who have already registered and paid the security deposit in earlier rounds (**Round-1 or Round-2**) **also must fill the online form by clicking “Apply Now” button through counselling website** within the stipulated date and time. If any such candidate failed to apply online within the scheduled date and time, he/she will **NOT be eligible** for Round-3 or any further round(s) in the Tripura NEET PG 2024 counselling. The **Final and Complete Merit list** of Tripura NEET PG 2024 Counselling for the academic session 2024-25 will be provided by NBEMS after completion of registration and application process.

The last date of surrendering/Resigning from admitted seat (Round-1 & Round-2) of Tripura State NEET PG 2024 Counselling will be the next day (up to 5pm) after the declaration of AIQ(MCC) Round-3 Counselling allotment result.

The schedule of other events of Round-3 of Tripura State NEET PG Counselling will be notified later.

**The requisite fees of a Tripura state domicile OBC (Non creamy layer) candidates will be as like requisite fees of general category candidate.*

Mandatory security deposit is a must for all intending participating candidates for participating in Round-3 counselling. If mandatory security deposit is not paid and the originals of transaction details is not uploaded/submitted in schedule time, then the candidate shall not be considered for allotment for any seat in Round-3 Counselling of Tripura State NEET PG 2024 Counselling.

The Mandatory Security deposit is refundable if not forfeited by specific events.

Instruction to the Candidates participating in Round-3 of Tripura State NEET PG Counselling

- 1) **Registration:** Online Registration is required for fresh candidates only and is **NOT** required for Round-1 & Round-2 already registered candidates. Registration fees shall have to be deposited through online counselling portal only. Documents of Eligibility, NEET PG 2024 score Card and all others relevant certificates shall have to be uploaded during Online Registration.

As per MCC notification published on 04-01-2025, the cut off percentile score for Round-3 of Tripura State NEET PG counselling 2024 is as follows:

- i) General Category/EWS- **15 percentile and above** will be eligible to participate in counselling.
- ii) SC/ST/OBC/ PWD category- **10 percentile and above** will be eligible to participate in counselling.

- 2) **Mandatory Security Deposit:** Mandatory Security deposit must be paid by

- i) Freshly registered candidates
ii) Candidates who have not paid the security deposit in earlier Rounds and
iii) Candidates whose security deposit had been forfeited.

The mandatory security deposit shall have to be submitted through bank demand draft/Bank deposit/online transaction. The demand draft shall have to be payable in favour of "**Directorate of Medical Education, Government of Tripura**" from any nationalized bank Preferably SBI.

All the candidates are requested to submit the original demand draft/counterfoil of original bank deposit/scanned copy of online transaction receipt mentioning the transaction number/ID to the office of the Director of Medical Education, Bidurkarta Chowmohani, Agartala on or before **13-01-2025 (up to 12 Noon)**.

A **scanned copy of original bank deposit/demand draft/online transaction** has to be **mandatory** uploaded online during application for Round-3 and/or onwards online Counselling.

Allotment of a seat shall **NOT to be considered** if the scanned copy of original transaction details of security deposit is not uploaded during online application for Round-3 Counselling and original demand draft/counterfoil of original bank deposit/scanned copy of online transaction is not submitted physically at the office of the DME within the stipulated time as stated.

A Candidate allotted a Round-2 seat but **NOT admitted** to the Round-2 seat can participate to Round-3 with **“forfeiture of Security Deposit”** and after freshly deposited security money again.

- 3) Candidates are instructed to participate in the “Choice filling” as per their fresh choices in the Counselling link: <https://dmeonline.tripura.gov.in> for allotment of seats as per seat matrix and category according to Merit. Round-1 or Round-2 choices shall be treated as null and void.
- 4) Once a candidate upgraded a seat in Round-3, previous admitted seat in Round-1 or Round-2 (if any) shall automatically get cancelled.
- 5) Candidates are instructed to follow the website of allotted Institutions for details regarding admission and other details.
- 6) If a candidate is allotted a seat in Round-3 counselling and **does not join** to the admitting institute, then the candidate will be **exited with forfeiture of security deposit and eliminated** for participating in any further rounds of counselling.
- 7) If a candidate is allotted a seat in Round-3 counselling and joined the admitting institute, then he/she cannot upgrade or resign.
- 8) All the candidates are requested to go through the information bulletin, Schedule, seat matrix, flow chart and earlier notifications issued by the Director of Medical education, Govt. of Tripura in respect to Tripura NEET PG 2024 Counselling to keep abreast of the counselling.
- 9) All the aspirant eligible candidates are also instructed to follow the DME website <https://dme.tripura.gov.in> at frequent intervals for further Notices/Updates/Notification which may be issued from time to time.




