**PGNEET MEDICAL– 2024 – CONDUCT OF SECOND STRAY VACANCY ROUND**  
(Instructions and Schedule)

Please refer this office notification dated 01-03-2025 published in KEA Website. Further, in view of the announcement of Special Stray Vacancy Round schedule by MCC for admission to PG Medical course for the year 2024, KEA is publishing the Second Stray Vacancy Round schedule for allotment of available PG Medical seats hosted on the KEA Website. Interested eligible candidates can participate for selection of available seats; they are advised to keep checking KEA Website for updates on seat availability / vacancy.

**1. ELIGIBILITY: Following candidates are only eligible to participate:**

- Candidates who are not holding the seat allotted in First Round or Second round of KEA or MCC or other state counselling; and
- Candidates not allotted seat in Round-3 or in the Stray Vacancy Round either through KEA or by MCC; (cancelled / not holding the pre / para clinical seat can participate) and
- Candidates not allotted seat in Special Stray Vacancy Round in MCC; and
- Candidates, who have newly registered, verified and deposited the original documents at KEA as per this office notification dated 01-03-2025.

**2. CAUTION DEPOSIT: (From 13-03-2025 up to 4.00 pm on 15-03-2025) (NEFT/RTGS/ ONLINE)**

- Candidates who have already paid caution deposit in the earlier round and did not get the PG Medical seat need not pay the caution deposit once again to participate in this second stray vacancy round.
- Other candidates who are willing to participate in the PGNEET 2024 Second Stray Vacancy Round should pay **CAUTION DEPOSIT** of Rs.5,00,000/- (Five Lakhs). If a candidate gets the PG Medical seat, Caution Deposit will be adjusted towards the fee. **CAUTION DEPOSIT** will be forfeited if a candidate gets the PG medical seat in the Special Stray Vacancy Round and fails to; pay the fees or to report to college, or take admission or likes to cancel the seat. (Candidate also has to pay the penalty amount as per rules – and the candidate will be barred from participating in the counselling including AIQ in the coming year) (List of Fee not paid candidates will be sent to MCC)

**3. DEPOSITION OF ORIGINAL DOCUMENTS AT KEA, BANGALORE:**

Deposition of original documents is mandatory to become eligible to participate in the Second Stray Vacancy Round. Candidates who have verified the documents and holding verification slip but did not deposit the original documents can deposit on **14-03-2025 (from 11.00 am to 1.00 pm)**. (Deposition is only by candidates in person, no one can represent the candidate)

**4. ENTRY OF OPTIONS: FROM 4.00 PM ON 13-03-2025 TO 16-03-2025 - 10.00 AM**

- (a) All eligible & interested candidates have to enter the options afresh in the order of priority. Options entered if any, in the earlier round will not be considered.
- (b) Verify and confirm the fees before entering the options.
- (c) Enter options you wish to join and by keeping in mind the penalty to be paid as per norms in case fails to join / cancel.

NOTE: Candidates will be considered for allotment only after confirmation of CAUTION DEPOSIT and options.

**NOTE:** Candidate will be barred from participating in the counselling including AIQ in the coming year in case if he / she wish to cancel the seat allotted in Stray Vacancy Round.

Any cancellation or surrender of seats after the mop up round shall be made in person only to the Director, Directorate of Medical Education, Karnataka with a penalty of Rs 18,00,000/- (Rupees eighteen lakhs only) in case of Medical Clinical Degree or Diploma Courses.

Provided that,-

- (a) A candidate who has opted Pre-Clinical seats like Anatomy, Physiology and Biochemistry including Forensic Medicine in the event of cancellation shall pay a penalty of Rs. 1,00,000 (Rupees One Lakh only) and the fees paid shall be forfeited;
- (b) A candidate who has opted Para Clinical Seats like Pharmacology, Pathology, Microbiology and Community Medicine, in the event of cancellation, shall pay a penalty of Rs. 2,00,000/- (Rupees Two lakhs only) for post graduate degree courses and Rs. 75,000/- (Rupees Seventy thousand only) for post graduate Diploma courses and the tuition fees paid shall be forfeited.

In addition to the prescribed penalty under sub-rule (4), all candidates (including in-service candidates) shall pay the entire course fee and stipend to the respective Medical/Dental colleges in the event he leaving the course before its completion.

5	Publication of Final Seat Allotment Results	17-03-2025 – after 11.00 am
6	Payment of Fees (after deducting the caution deposit amount)	17-03-2025 to 19-03-2025 – 2.00 pm
7	Downloading of admission orders	Up to 19-03-2025 – 4.00 pm
8	Last date for reporting to the college	19-03-2025 – 5.30 pm (Dates will not be extended further – as per MCC)
