PUBLIC NOTICE FOR STRAY ROUND SCHEDULE (MD/MS/DNB/DIPLOMA COURSES)

It is for the information of all the eligible candidates desirous of seeking admission to **MD/MS courses** in all Government/ Government Aided/ Private Unaided Medical Institutes including those under Private Universities - SGT University, Budhera, Gurugram, Al-Falah University, Village Dhoj, Faridabad, MMU Sadopur, Ambala and **Post MBBS DNB/Post MBBS Diploma courses** in Civil Hospitals/Medical College in the State of Haryana for the Academic Session 2025-26, the tentative schedule for **Stray Round** counseling is as under:

Note:-

- The candidates, who have already registered themselves upto Round-3 and wish to participate in the **STRAY VACANCY ROUND**, shall not be required to register again.
- The candidates, who have been allotted seats in round-3 Haryana state counseling shall not be considered eligible for the **STRAY VACANCY ROUND** of counseling.
- The candidates, who have been allotted seats in Stray Round through All India Counseling shall not be considered eligible for the **STRAY VACANCY ROUND** of counseling.
- The Candidates, who have already admitted/joined on any seat allotted to them upto round-3 through All India Counseling/Any State counseling seat shall not be considered eligible for the **STRAY VACANCY ROUND** of counseling even after resignation.
- All candidates (already registered (irrespective of their admission status) and freshly registered candidates} who wish to participate in the **STRAY VACANCY ROUND** of counseling and want to opt for State Quota Seats in only **Government/Govt Aided Medical Colleges** shall be required to deposit online an amount of Rs. 25,000/- (Rs. 12500/- for **SC/SCD/BCA/BCB/EWS/PWBD of Haryana State**) and if the candidate wishes to also opt for **State Quota Seats/Management Quota Seats in Private Medical Colleges including Private Universities** then he/she shall have to deposit online an amount of Rs. 5.00 Lakh. This facility shall be available in the login ID of the candidates on admission webportal. In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the **STRAY VACANCY ROUND** of counseling.

6. In case of candidate join on the allotted seat, this security amount shall be adjusted in the tuition fee of the first year of PG Course.
7. ***If the candidates are allotted any seat as per their preference in STRAY VACANCY ROUND, but they do not join on the allotted seat, the security amount shall be forfeited and these candidates will not be eligible to participate in the further round(if any).***
8. The security amount of the candidates who are not allotted any seat during the **STRAY VACANCY ROUND** shall be returned after the completion of the counseling process.
9. **The candidate who have been allotted/joined seat to them during the All India Quota/Any State upto Round-3 of counseling shall not be eligible in stray/ further round of counseling.**
10. **In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the security amount fee shall be forfeited.**
11. **As per Govt. of Haryana notification dated 10.11.2025, Clause 10(xv), "after exhaustion of merit list of the candidates who have applied under various reserved categories, vacant seats (if any) shall be reverted back to their original category(ies) of seats as per State Reservation Policy and filled up as per merit after conversion (For eg. BC-A seat to BC-B and finally to UR) and filled up in the 3rd round itself for both Government and Private Institutes. However, in case of any seat falling vacant after the 3rd round in any category, it shall first be offered to candidates belonging to original category of vacant seat of the previous round. In case, if the seat still remains vacant, the same shall be filled as per system in the 3rd round and so on".**

Note: -

- i. The choices filled by the candidates upto Round-3 of counseling shall be treated as null and void and the candidates will have to fill fresh choices.
- ii. The above instructions should be read in accordance with NEET PG information bulletin 2025 and Govt. of Haryana notification dated 15.09.2025 & 10.11.2025 and public notices issued time to time.
- iii. Govt. of Haryana notification No. 40/13/2024-1SW dated 16.07.2024 is applicable for BC-A/BC-B category candidates.
- iv. Any modification in terms & condition will be applicable as per guidelines issued by MCC/Govt. of Haryana.
