In continuation to the notification dated 22.01.2025, revised schedule for round 3 allotment process for MD/MS, Post MBBS DNB and Post MBBS Diploma courses in Rajasthan, is as below:

Deposition of prescribed one year tuition fee by allotted candidates through NEFT and RTGS only (No other mode of fee deposition will be accepted) Refer Important Advice for online payment of Security Amount/Tuition Fee available at the website.	11.02.2025 to 14.02.2025 (5.00 pm)
Reporting, document submission (including prescribed eligibility criteria) at the allotted college desk at Academic Block, SMS Medical College, Jaipur along with printout of allotment letter, all original documents, required bonds etc. and 2 copies of application form along with Self attested photocopies (one set) of all relevant documents as listed in information booklet Note: (i) Candidates having joined status upto Round 2 who get upgraded in Round 3 shall bring fee receipt issued by Round 1 / Round 2 joined college and will complete all other formalities of allotted college (their original documents will be transferred directly to Round 3 upgraded college). (ii) Candidates having joined status upto Round 2 who filled choices for upgradation but not upgraded to Round 3 (allotted same college and same course in Round 3) need not report again for the same college.	12.02.2025 to 15.02.2025 (2.00 pm)

1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. All such candidates having joined status upto Round 2 who retain their seat in Round 3, will have to complete all other formalities of their allotted college (Refer to respective College Website) at the time of joining for Round 3.
3. The candidates are advised to visit the websites regularly for registration and other relevant information.

Candidates having joined status on completion of round 2 and upgradation in round 3 with re-registration are required to refer point number 7 under the heading 'Security amount' of Instruction Booklet, which is reproduced hereunder:-

"7. A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3 will be eligible only on fresh application and on depositing security amount again. His/her earlier deposited security amount will be forfeited."

It is worthwhile to mention here that the security amount deposited in earlier round by a candidate (having joined status on completion of round 2 and applied afresh for upgradation in round 3), has been forfeited in accordance to the above clause.

Whereas the security amount deposited earlier was already adjusted in the tuition fee deposited by the candidate, hence it is notified to all concerned that on forfeiture of the above security amount, the concerned candidate shall be bound to deposit the amount (equivalent to the security amount as forfeited) to the concerned college joined upto round 2 (towards due amount of the tuition fee) upto the last date of the fee deposition of the round 3 counselling, failing which the allotment / admission of such a candidate shall stand cancelled.
