Subject: Re-assessment for Renewal of MBBS Seats to Shri Rawatpura Sarkar Institute of Medical Sciences and Research, Raipur, for AY- 2025-26 in compliance to Hon'ble High Court of Delhi order dated 11.09.2025 - Regarding.

Sir/Madam,

Reference is invited to earlier disapproval order dated 18.07.2025 w.r.t renewal of MBBS seats for AY 2025-26 of your Institute issued by the Under Graduate Medical Education Board (UGMEB), an autonomous board under National Medical Commission (NMC).

- 2. Besides deficiencies w.r.t minimum standards requirement; the above disapproval order dated 18.07.2025 was issued on account of FIR being lodged by CBI alleging the involvement of college authorities. However, the same was challenged by the college before Hon'ble High Court of Delhi in WP (C) No. 13299/2025. The Hon'ble High Court of Delhi in the hearing held on 11.09.2025, passed an order and directed as under:
 - a. The National Medical Commission shall satisfy itself by securing another inspection report from the Expert Committee by 17.09.2025 and thereafter shall take appropriate decision as to whether the petitioner – institution is to be permitted to take the intake of MBBS students for the academic session 2025-26.
 - b. If the National Medical Commission is satisfied about the compliance of the statutory norms, it shall ensure that adequate number of students strictly as per merit are provided for admission against the sanctioned seats by the body/ authority conducting the counselling.
 - c. It is clarified that the direction contained in this order shall have no bearing on the FIR registered by the CBI and the proceedings on the basis of the said

FIR shall independently be carried out in accordance with law.

3. In compliance of above mentioned directions, the Medical Assessment and Rating Board (MARB) conducted a virtual inspection of the college on 16.09.2025, as per the procedure laid under Section 26 of NMC Act. On receipt of above virtual inspection report, the UGMEB got the same scrutinized by the experts on 18.09.2025. As per the expert scrutiny report, following deficiencies have been found in the college:

Observations of Experts are as follows:

- The arrival of the assessors was recorded at 9.30 A.M on 16.09.2025.
- Successful establishment of the virtual connection was not achieved.
- Repeated interruptions in communication were experienced even after the commencement of the assessment.

Faculty/Tutors/Senior Residents

Deficiency was observed in all departments.

OPD Attendance and Bed Occupancy

- Required data was provided very late.
- Submitted data did not match the visuals of the live feed.
- Hospital areas were mostly found without patients or with very few patients
 Departmental Faculty Deficiency
- Anatomy Department: 50% deficiency is observed.
- Forensic Medicine Department: 100% deficiency was observed and only one tutor appeared during the head count.
- Dermatology Department: 50% deficiency is observed.

Clinical Investigation Data

- Details requested were provided late in the evening
- Histopathology data were not found corresponding to the number of surgeries performed.

Additional Findings:

• On inspecting AEBAS data it is observed that multiple faculty that were present even less than 30% of working days.

Further analysis of AEBAS attendance status on the NMC portal reveal that there is cumulative deficiency of 35% against the overall required faculty as per MSR-23. The faculty deficiency has been esp. found in department of Anatomy, Anesthesiology, Community Medicine, Dermatology, Forensic Medicine & Toxicology, General Medicine, Microbiology, Ophthalmology, Orthopedics, Oto-Rhinolaryngology, Pediatrics, Pathology, Psychiatry during the preceding 05 months period w.e.f. 01.04.2025 to 31.08.2025.

4. The Expert Sub-Committee of UGMEB examined the above mentioned documents and inputs. After detailed review, the Sub-Committee expressed serious concern over the persistent deficiencies observed in faculty availability and clinical parameter despite being provided an additional opportunity for compliance

through a re-inspection (as per the Hon'ble High Court's directions), the institution has failed to show improvement, both in terms of faculty and hospital clinical parameters. Also, the college authorities did not cooperate properly with the inspection team during the virtual inspection held on 16.09.2025. In light of the above, and to safeguard the quality of Medical Education and ensure adherence to regulatory norms, the Expert Sub-Committee recommended a reduction in the permitted intake from 150 to 100 MBBS seats for the Academic Year 2025–26.

- 5. In view of the above, the competent authority has decided to grant the conditional renewal of 100 MBBS seats (reducing 50 from 150 seats) for the Academic Year 2025–26 to your Institution, subject to removal of deficiencies within 3 months period. Consequently, the earlier order issued by this office vide letter No. Renewal/UGMEB/2025-26/54 dated 18.07.2025, for disapproval of renewal of MBBS seats to your institution, is hereby withdrawn with immediate effect.
- 6. In the event that your institution is aggrieved by the decision of the Board, you are entitled to file an appeal before the National Medical Commission under Section 9, Chapter IV of the *Maintenance of Standards of Medical Education Regulations*, 2023 (MSMER, 2023). Any such appeal must be lodged within sixty (60) days from the date of issuance of this communication.
- 7. This issue with the approval of the Competent Authority.
