As per the Notice No.08, the Schedule for CAP-3 was postponed in accordance with AIQ round 3. Now, National Medical Commission (NMC) has reduced the qualifying criteria for admission to Post Graduate Medical Course. In accordance with the schedule published by Medical Counselling Committee (MCC) for State Counselling and to allow registration of newly qualified candidates, the schedule for State CAP-3 and Online Stray Vacancy round is declared as below.

Especially for EWS candidates, the format as per **Annexure A** is only valid and **Annexure I** will not be considered for admission through State Quota.
- 4) Candidate should ascertain the fees for the unaided private college well in advance through the concerned college website or Fees Regulating Authority (FRA) website before filling up the choices.
- 5) Candidates claiming PWD quota should have certificate issued by any one of the authorized boards in Online format. Certificate from any other authority will not be considered.
