The activities related to the third phase of allotment to the Kerala Avurveda/ Homoeopathy / Siddha Unani /Agriculture/ / Veterinary/Forestry/Fisheries/ Co-Operation & Banking/ Climate change & Environmental Science/ B.Tech Biotechnology courses (Under Kerala Agricultural University) for the State Quota Seats have commenced.

Online Option Confirmation is mandatory

Those Candidates who want their higher order options in Ayurveda/ Homoeopathy /Siddha /Unani and Medical Allied courses to be considered in the third phase of allotment, shall have to log onto their Home page and confirm their options by clicking the 'confirm' button available therein. After Online Option confirmation, the candidates can re-arrange their higher order options/ delete the unwanted options till 24.10.2025, 11.00 AM through the website www.cee.kerala.gov.in.

Online option confirmation is mandatory for those who have got admission and those who have no allotment as per the previous phase allotments, to be considered in the third phase allotment. If the candidate does not confirm his/her options, the existing admission as per the second phase allotment shall be retained. The unallotted category seats will be converted during this phase.

On the basis of options received up to 11.00 AM on 24.10.2025, the third phase provisional allotment to Ayurveda/ Homoeopathy /Siddha /Unani and Medical Allied courses will be published in the website

www.cee.kerala.gov.in on 25.10.2025. The final allotment will be published on 27.10.2025. Candidates who receive allotment in this phase shall have to take a printout of their allotment memo and remit the fee/balance fee (if applicable) shown in the allotment memo, to the allotted colleges and should join the course/college allotted.

FEES

The details of fee for the Ayurveda / Homoeopathy /Siddha /Unani and Medical Allied courses, in various colleges is available in the website. Candidates allotted under SC/ST/OEC category and those having benefits as per G.O((MS)25/2005/SCSTDD, dated: 20.06.2005 and G.O(MS)10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra Home, Juvenile Home, Nirbhaya Home need not to pay the fee at the time of admission. However, if such candidates are allotted under Management quota seats , they will have to remit the fee as shown in the allotment memo and they will not be eligible for any fee concession.

Note:

1. Candidates are instructed to confirm options to the courses/colleges to which they are sure to join and continue studies if allotted. The allotment of those candidates who do not take admission within the stipulated time will be lost and such candidates will not be considered

for further centralised allotment for courses in the medical & medical allied stream.

- 2. The candidates included in the ineligible list of AACCC dated 17.10.2025, will not be considered for the third round allotment in the State.
- 3. Those candidates, who wish to vacate the seats joined through Phase I & Phase II, can exit the seat by forfeiting the Option Registration fees on or before **24.10.2025**, **5.00 PM**.
- 4. Vacancy, if any, exists after the third round allotment will be filled up through Stray Vacancy Allotment. The details of Stray Vacancy Allotment will be published later.
