# ADMISSION TO PG MEDICAL COURSES-2024 THIRD PHASE ALLOTMENT PUBLISHED

The Third Phase Allotment for admission to the P G Medical (Degree) courses 2024 to fill up the vacant seats in the Government Medical Colleges in the State, Regional Cancer Centre (RCC), Thiruvananthapuram and Private Self Financing Medical colleges is published in the website **www.cee.kerala.gov.in**.

To view the Allotment Result, candidates should log on to the 'PG Medical 2024-Candidate Portal' by submitting their Application Number and Password. Then by clicking on the link 'Allotment Result', candidates can view their Allotment Result. It is necessary to take the printout of Allotment Memo. The allotted candidate should report for joining at the allotted colleges from 12.02.2025 to 15.02.2025, 4.00 PM along with the required documents specified in the Allotment Memo and Prospectus.

Course once allotted in the third phase shall be final. Surrender of seats after allotment in the third phase will not be permitted. A candidate who joins a seat in this allotment and then vacates the seat for any reason will be liable to pay liquidated damages as per the clause 10-2.3 of Prospectus. Candidates who are allotted a seat in the third phase allotment (irrespective of the admission status) will not be eligible for any subsequent allotments.

All the college authorities should approve the list of admitted candidates through the Online Admission Management System (OAMS) at **5.00 PM on 15.02.2025**.

## **Stray Vacancy Filling Phase**

After the 3<sup>rd</sup> Phase allotment, if any vacancies exist or arise, those vacancies shall be filled through Stray vacancy allotment. There will be fresh option registration for Stray Vacancy filling phase. The net vacant seats due to un-allotted/non joining of Phase 3 will be published. If vacancies exist

even after an initial stray vacancy allotment and if there is sufficient time before the cut-off date for admissions prescribed by National Medical Commission, additional stray vacancy allotments may be conducted based on the options registered for the Stray vacancy filling phase. If any candidate vacates a seat joined in Stray vacancy allotment or vacates a joined seat (joined in any of the previous phases also) after Stray vacancy allotment process, he/she will be liable to pay liquidated damages as per clause Clause 10.1.19 (4) of the Prospectus.

Candidates are requested to go through the various provisions with regard to the allotment process in the Prospectus for admission to PG Medical Courses-2024 available on the website **www.cee.kerala.gov.in** and also requested to visit the website regularly for updates.
