

**Instructions for Uttarakhand State NEET PG-2024 Round-III Online**  
**Centralised Counselling**

1. The following category of candidates are eligible for UttarakhandState NEET PG-2024 Online Centralized Round-III of Counselling -
  - ❖ Only those candidates are eligible whose name is mentioned in the **STATE SPECIFIC MERIT LIST FOR THE STATE OF UTTARAKHAND** prepared by NBEMS, New Delhi. (List uploaded on the University website)
  - ❖ **All such candidates have to Re-registered themselves to become eligible to participating in Round-III of counselling.** If any candidate's whose name is mentioned in **STATE SPECIFIC MERIT LIST FOR THE STATE OF UTTARAKHAND** but he/she do not re-register him/her self for round-III counselling he/she not eligible for round-III of counselling.
  - ❖ All Candidates who have taken admission against seat allotted in round-I & II are eligible for seat/college/quota up-gradation in round-III of counselling after re-registration for round-III Counselling.
  - ❖ Already Registered candidates who have not taken admission against the round I &II of allotment or have withdrawn after taking admission are also eligible to appear in round-III of counselling after re-registration for round-III Counselling.
2. If the candidate is not interested to participate in round-III of counselling or is satisfied with the allotted seat. He/she is advised not to re-register/fill choice in round-III of counselling, so that the seats can be allotted to the eligible re-registered candidate in order of merit & to curb the malpractice of seat blocking.
3. Already registered candidates who wish to change the college (Private/Govt.) can do so by selecting the following option: -
  - The Candidates who participated in round I and II and opted for Government colleges only by paying the required security fee but now want to opt for private college, will have to deposit the security fee of Rs 200000/- for round-III (the security deposit paid in round I or II will be refunded separately).
  - The Candidates who participated in round I and II and opted for Private and/or Govt colleges both by paying the required security fee of Rs. 200000.00 but now want to opt for Government colleges only are not required to deposit the security fee again (the balance security fee paid in round I or II will be refunded separately).
4. ***The candidates who fail to complete the formalities of round-III of counselling like re-registration, and fresh choice filling within stipulated time will not be considered eligible for round-III of seat allotment. Hence candidates are advised to read the counselling schedule and complete the formalities on the prescribed time line.***

5. ***If the candidate surrenders his/her allotted and/or admitted seat of round-I & II. His/her security deposit fee will be forfeited by the counselling board. However, such candidates can participate in round-III counselling by re-registering himself and deposit the required security fee again.***
6. After final submission if a candidate wishes to edit any information within time schedule of registration, the candidate has to pay an additional fee of **Rs.500/-** only each session for editing (only by online mode). For this candidate has to click “**CORRECTION FEE**” link after Login. Under any circumstance NO time extension will be permitted for editing the information. After editing the previous entries & Hard copy of print out will be treated Null & Void.
7. Allotment on available State Quota seats /All India Quota and NRI Quota seats for NEET PG-2024 Uttarakhand State Round-III of Online Centralized Counselling will be held purely on the basis of NEET PG -2024 State Specific merit-cum-preferences of the interested eligible candidates.
8. The seats remaining vacant in vertical and horizontal category due to non availability of eligible interested Reregistered candidates will be converted to other categories as per rules in the third round of counselling.
9. In Round III the clause/Condition of Security fee Forfeiture will apply, the Candidates are advised to select the choices for round-III very carefully. If candidates are not interested in any specific subject/ specialization/college/ quota, it is advised not to select that specific subject/ specialization/college/ quota in choice filling process.
10. ***If a candidate fails to secure the admission in the seat allotted of round-III of counselling the security fee deposited by the candidates stands forfeited. Such candidates cannot participate in stray vacancy/further round of counselling.***
11. If the candidate gets the allotment against the new choice, the seat allotted in the first and/or second round will be automatically cancelled and will be allotted to next eligible Reregistered candidate. The Counselling board/University will not be responsible for any mistake committed on the part of the candidates during choice filling.
12. ***If the candidate does not get the allotment against the new choice, the seat allotted in the first and second round will be retained by the candidate and he/she will not be permitted to vacate/surrender the admitted seat of round-I and round-II.***
13. Candidates must keep a printout of choice filled for future reference.
14. All the interested eligible candidates are advised to select as many choices as per their preference(s) irrespective of seat status shown in seat matrix.
15. These choices will be valid only for III round of counselling.
16. The allotment letter will be available to the candidate along with necessary instructions through the University website. The printout of this allotment letter will have to be

produced by the candidate at the time of admission to the college allotted to him/her. No extension will be permitted for last date of admission.

17. Candidates who have been allotted the seat have to report to the concerned college in person along with all required original documents for verification as well as the balance required fee (other than advance tuition fee) for confirmation of admission.
18. The candidates who have taken admission against the seat allotment of Uttarakhand State NEET PG-2024 round-I & II counselling have a last opportunity to vacate the allotted seat with forfeiting security deposit. The last date to vacate the seat will be by 27-01-2025, 05:00 PM through at the admitted college only. After 27-01-2025, 05:00 PM candidate will not be permitted to vacate the seat under any circumstance.
19. The candidates who secure to the admission a PG seat in round-III of seat allotment will not be permitted to vacate/surrender the seat. The counselling board will not be responsible for any negligence in the part of the candidate.
20. Stray vacancy Round/ Further round of counselling will be held subject to the availability of vacant seats only and detail guidelines will be intimated separately.
21. Please refer to Information Bulletin- NEET PG 2024 for further information.
22. Any or all the above-mentioned rules and regulations may change as per the directions of the Hon'ble Court(s)/ regulatory bodies/State Government.
23. The candidates already under bond for compulsory service in Uttarakhand have to fulfil the conditions mentioned in the bond or as specified by State government, DGH&FW, Uttarakhand and Hon'ble High Court from time to time. The Counselling board/University will not be responsible for any legal issues arising out of matter related with such bond or service conditions.
24. In-service candidates of State of Uttarakhand/other states/central Government/PSU, etc will also have to fulfil the conditions mentioned in their service rules.
25. The security fee will not be adjusted against the Tuition or any other Fee. The security fee (if not forfeited)/excess deposit (if any) will be refunded separately only after one month of completion of Last round of counselling.
26. The latest information and procedure of counselling will be uploaded on university website on the basis of directions/advisories received from Govt. of India, Medical counselling Committee, NMC, Govt of Uttarakhand from time to time. The latest directions uploaded on the website by UK NEET-PG counselling board will only be applicable and will replace any such condition/term/rules mentioned in the information

bulletin. The decision taken by UK NEET–PG counselling board related to procedure of counselling will be applicable at all time. Hence candidates are advised to visit the university website regularly for any update. No separate information will be sent to the candidate.
