GENERAL INSTRUCTIONS:

- ❖ Candidates who had registered for Round-1 and did not get any seat allotted are not required to register again. Also, candidates who have been allotted but not joined in Round-1 need not register again.
- ❖ Candidate who have joined the seats and wish to opt for upgradation need not register again.
- ❖ Fresh registration is permitted in Round -II for those candidates who have not registered in Round-1 (with full payment of fees. But, candidates should have already applied to Tamil Nadu Medical Selection Committee and their names should be in the Merit List published)
- ❖ Candidate who wish to retain their seats (who don't want a change in college) need not participate in this Round.
- ❖ If opted for and upgraded in Round 2, the candidate **has to relinquish** the seat from Round 1 and join Round 2 allotted seat. He/She will not have any rights over the Round-I seats.
- ❖ Round- II choice filling will follow the registration and candidates who wish for upgradation, un-allotted candidates and not joined candidates have to fill their choices.
- ❖ Candidates should be careful while choice filling and it is advisable to choose preferred colleges only.
- ❖ Candidate could edit their Choice(s) but once the candidate locks their choice(s) during the online counselling, it cannot be changed later.
- ❖ If the candidate is re-allotted in Round 2, then the MBBS/BDS seat allotted to candidates during Round 1 of Counselling will be allotted to other candidates **in descending order, not in ascending order.**

- ❖ Candidates can discontinue the course before the stipulated resignation date. These candidates will be eligible to attend the subsequent Rounds of online counselling for the academic year 2024-2025.
- ❖ If the candidate has joined but Discontinued the course after the stipulated date of resignation he /she will be eligible to attend the Round-3 of online counselling for the academic year 2024-2025, but they will have to forfeit the registration fee and Security Deposit paid by him/her.
- ❖ Candidates who participated in Round-2 but were allotted the same seats will be considered as Retained and have to follow the same Round -2 Rules as mentioned the above two clauses.
- ❖ Candidates who are freshly allotted seats in Round 2 but who don't report or join the allotted institute can participate in further Rounds (without forfeiture).
- ❖ Candidates getting upgraded in Round 2 shall NOT have any claim on Round 1 seat (Even if they don't report or join their Round -2 seats).
- ❖ Seat Matrix for the Course will be available on the official website.
- ❖ Candidates can edit their choices any number of times before locking, but once locked they will not be allowed to edit.
- ❖ Selection committee does not take responsibility for Connectivity error and Procedural error.
- ❖ Admission to MBBS/BDS Degrees courses shall be made by the ONLINE COUNSELLING on the basis of rank by applying the rule of reservation.
- ❖ **Virtual vacancies:** Any candidate who has been allotted a seat in Round 1 and has opted for upgradation by registering in the website in Round 2, that allotted seat of Round 1 will be shown as virtual vacancy in Round 2 and all candidates can fill their choice for the said seat during the choice filling in Round 2. However, such seats will be allotted in Round 2, only if

the allotted candidate of Round 1 vacates/upgrades in Round 2 then that virtual vacancy becomes a real vacancy.

- ❖ All candidates should read the Prospectus thoroughly before starting choice filling.
- ❖ Candidates should be careful while choice filling.
- ❖ **Choice Filling:** Candidates will have the option of choice filling for the categories for which they have applied in Round-I. For example, if a candidate has applied for both Government and management quota he will have choices for both Government as well as Management quota. The candidates are encouraged to analyse the choices available and fill their choices in order of their preference.
- ❖ If the candidate does not lock his/her choices till the last date (16.09.2024 AT 05.00 PM) their choices will be automatically locked.

INSTRUCTIONS FOR DOWNLOADING ALLOTMENT ORDER:

- ❖ The freshly allotted candidate for MBBS seats in all colleges under all categories and BDS seats in Government Dental Colleges has to pay the Tuition Fee for downloading the Provisional allotment order (Except candidates mentioned in the next clause) through online via Debit Card / Credit Card/Net Banking or RTGS.
- ❖ The Selected candidates belonging to SC/SCA/ST/SCC who have been allotted seat in Govt. Quota and Management Quota are exempted from paying tuition fee for downloading the allotment order if annual income of Parents/ Guardian is less than 2.5 Lakhs.
- ❖ The Selected candidate (BDS seats in Self Financing Dental Colleges) has to pay the Tuition Fee at the time of admission to the colleges directly as per G.O(D) No.868 Health and Family Welfare (MCA-1) Department dated.18.07.2023 as detailed in the Notification No.010/SCS1(1)/2023 dated 19.07.2023.
- ❖ The re-allotted candidates who already paid the tuition fee in the Round-I of online counselling, have to pay the difference (if any) amount only.

- ❖ Fee structure is available in the official website www.tnmedicalselection.org
- ❖ All candidates should make sure, sufficient fund is available at their bank account with expanded credit/Transaction limit while remitting their Tuition Fee.
- ❖ The allotted/re-allotted candidates should download their provisional allotment order and join the course in the concerned Medical College/Institution on or before the stipulated date and time as mentioned in the Provisional Allotment Order.

REPORTING TO ALLOTTED COLLEGE:

- ❖ The Certificate Verification will be done in the selected colleges itself.
- ❖ The candidates should produce their ORIGINAL CERTIFICATES in person at the time of joining in their selected Colleges along with the scanned copy of original certificates for verification.
- ❖ If you do not report to the Head of the Institution to which you are allotted on or before the time and date specified, your selection and / or admission will be cancelled without any further notice.
- ❖ The Candidate selected for admission should give a self-declaration form at the time of the reporting to the concerned College that he/she is liable for forfeiture of selection / admission if suppression of facts, mis-interpretation is found at any time during or after the admission to the course.
- ❖ Candidates are advised to be in touch with our official website (www.tnmedicalselection.org) for Schedule / latest updates / Results / Notices / News & Events pertaining to counselling as Selection Committee will not be individually contacting the candidates for the same.
- ❖ No communication will be directly sent to the Candidates. They are advised to be in touch with the website on regular basis for any updates.
