ONLINE COUNSELLING FOR ADMISSION INTO 1ST YEAR MBBS/BDS COURSES IN THE GOVERNMENT MEDICAL & DENTAL COLLEGES OF ASSAM FOR THE SESSION 2024

In continuation of this Directorate's earlier Notice vide No. e.DME/UG/17/2024/2668, dated 3rd October, 2024, this is for information of all concerned that the 2nd round Online Counselling for Admission into the vacant MBBS/BDS seats in the Government Medical and Dental Colleges of Assam for the session 2024 under State quota seats, which was kept on hold, has been merged with the 3rd round Online Counselling, which will now start from 16/10/2024 as per schedule given below.

Online Portal for the counselling will be available at the official website of this Directorate www.dme.assam.gov.in from 16/10/2024. Online Registration will be available for eligible candidates who could not register for counselling during 1st and 2nd rounds of registration. Candidates who had already registered successfully need not register again. Choices filled by registered candidates during choice filling for 2nd round of counselling shall remain valid. However, if any such candidate wants to revise his/her choices, may do so during the choice filling for merged 3nd round of counselling. The provisionally selected candidates shall have to get admitted in the respective allotted Medical /Dental College on 22/10/2024 or 23/10/2024 during office hours.

Candidates who were admitted in $1^{\rm st}$ round of counselling and subsequently allotted another Medical /Dental College, shall have to report to the newly allotted Medical/Dental College with the acknowledgement receipts/documentary proof of submitting the certificates/testimonials etc. issued by the previous Medical /Dental College.

Any candidate, who is allotted a new Medical/Dental College on his/her choice in the counselling, the previous allotment of the seat shall automatically be cancelled and a new candidate shall be allotted to the vacant seat. It is therefore to be noted that if an admitted candidate, who is allotted a new Medical/Dental College on his/her choice and does not join in the newly allotted Medical/Dental College within stipulated date and time, he/she shall be considered as not joined and shall not have any claim over the seat.

It is also to be noted that candidates who attended Office of the DME, Sixmile, Khanapara, Guwahati-22 on 5th October 2024 for documents verification and filling of choice of Institutions under **5% Government School reservation** and are found eligible for the said reservation, the candidates shall be allotted Medical /Dental Colleges in order of merit and their choice. The provisional select list shall be published along with the result of merged 3rd round counselling.

It is pertinent to be mentioned here that after joining the institute following 3rd round of online counselling, the candidates shall not be allowed to participate in the subsequent counselling.
