As per the letter no. सं.सं.-1/प.नि.-06/2024-700(1) dated 14.10.2024 of the Deptt. of Health, Govt. of Bihar the nominations or allotment of seats for admission in various Post Graduate Medical courses including MD / MS / PG Diploma shall be made according to merit-cum-choice on the basis of the Competitive Test as conducted by National Board of Examination, New Delhi i.e. NEET (PG)-2024.

1. SHORT TITLE, EXTENT AND COMMENCEMENT:

- (i) This Prospectus may be called 'Post Graduate Medical Admission Counselling Prospectus 2024.
- (ii) It shall extend to the whole of the State of Bihar.
- (iii) It shall come into force at once.

2. **DEFINITIONS**:

- (i) 'College'-Means Medical Colleges in State of Bihar which are established or financially aided by the Bihar Government or established and run by private management / corporation and included in the schedule of Medical Council of India / National Medical Commission.
- (ii) 'Course'-Means Post Graduate Medical courses of study i.e. MD / MS, Diploma & DNB (Degree / Diploma) courses.
- (iii) 'Examination'- NEET(PG)-2024.
- (iv) 'Board'– Means Bihar Combined Entrance Competitive Examination Board, Government of Bihar.
- (v) 'Government'– Means State Government of Bihar.
- (vi) 'Controller of Examination'- Means Controller of Examination, Bihar Combined Entrance Competitive Examination Board, appointed by the Government.
- (vii) 'He' includes 'She'.
- (viii) 'Bihar' Means Bihar after reorganisation as defined under section-4 of the Bihar Reorganisation Act-2000.

3. Admission Test:

Nomination or allotment of seats for admission in various Post Graduate Medical Courses, i.e. MD / MS Degree, Diploma Courses & DNB (Degree / Diploma) courses shall be made on merit-cum-choice basis on NEET (PG)-2024 conducted by National Board of Examination as provided in this prospectus.

4. Post Graduate Courses:

MD/MS - Degree & Diploma & DNB (Degree / Diploma) Course Group: This group includes the following-

- a) MD / MS / Diploma course available in Medical Colleges.
- b) DNB (Degree / Diploma) Courses for In-service doctors working in Bihar Government on regular basis.

5. Institutions / Available seats (MD / MS / Diploma Course) in Govt. & Private Medical Colleges :

 - iii. DNB (Degree / Diploma) seats for In-services doctors working in Bihar Government on regular basis.
 - iv. For allotment of PG Medical seats in Private Medical Colleges, the reservation arrangement of the concerned institutions shall be applicable.
 - v. Fee structure & other details regarding admission to PG Medical Degree course in Private Medical Colleges is uploaded on Board's website as well as concerned colleges website.
- 5.2 If the Government of India / NMC / Appex body gives approval to start new courses or to increase the number of PG Degree / Diploma Seats in any course/ Institution, the coursewise/ Institution wise / Category wise seat distribution will be revised to that extent and the allotment will be made accordingly in the current session. Hence State Govt. reserves right to add new Institutions and seats in this statement at any time for which information will be provided at the time of online choice filling.
- 5.3 As communicated by the Deptt of Health, Govt. of Bihar vide ज्ञापांक सं- 1/विविध-74/2016-404(1) दिनांक 06.04.2021 and in the light of अधिसूचना संख्या- भा.आ.प.-18(1)/2016-मेडि./176290 दिनांक 10.03.2017, of Govt. of India the admission agaist all PG Medical seats available in Govt. and Pvt. Medical Colleges of Bihar will be filled by the NEET PG-2024 qualified candidates on the basis of common counselling to be conducted by BCECE Board.
- 5.4 (a) (i) 50% seats of the Post Graduate Diploma courses, available in Govt. Medical Colleges of Bihar, will be reserved for Bihar Health Services Doctor as well as Contractual Doctors in the Bihar Govt. Service, who have served for atleast three years in remote and difficult areas of the state notified as per Health Department, Govt. of Bihar vide notification no. संख्या-2/कोर्ट-59/13-695(2)/स्वा, दिनांक 17.06.2014.
 - (ii) If eligible candidates are not available after the allotment of diploma remote seats in any reservation category, such remaining vacant seats will opened in respective categories of Diploma Open Seats.
 - (iii) For being eligible for the above mentioned reservation, the concerned Medical Officer will have to upload certificate (Annexure-3) duly issued by the Civil Surgeon of the concerned District

and countersigned by the District Magistrate of the same District, that he has rendered Govt. service in remote / difficult areas of the state as has been identified by the Deptt. of Health, Govt. of Bihar vide notification no.-2/Court-59/13-695(2) dated 17.06.2014 for a period of minimum three years at the time of filling online application.

- (iv) Such candidates, who have been allotted PG Diploma Remote Seat, will have to upload an undertaking in the format given in Annexure-2, that he/she is ready to serve for a further period of two years in remote / difficult areas of the state, at the time of uploading of documents during Document Verification and Admission.
- (v) As communicated by the Deppartment of Health, Govt. of Bihar vide letter number no. মান্দা-1/प.নি.-06/2024-700(1) dt. 14.10.2024 that decision taken vide departmental letter no. 1314(2) dt. 20.09.2024 benefit of weightage for admission in Post Graduate Medical courses to those doctors who served in rural area for at least 2 years against **floating post of medical officer (contractual)** will be given.
- (b) (i) As communicated by the Department of Health, Govt. of Bihar vide letter no. सं.सं.-1/प.नि.-04/2020(पार्ट-2)-623(1) दिनांक 26.06.2020, incentive marks upto maximum 30% in terms of Regulation 9 (iv) issued by the Medical Council of India vide notification no. MCI-18(1)/2018-Med./100818 dated 05.04.2018 will be provided for admission in PG Degree Courses to the Medical officers who are in service of Bihar Govt./ Public authority in remote / difficult area notified as per Health Deptt., Govt. of Bihar vide notification no. सं.सं.-2/कोर्ट-59/13-1037(2)/स्वा. दिनांक 27.08.2013.
 - (ii) Such eligible candidates must upload their work experience certificate in the format issued by Department of Health, Govt. of Bihar vide letter no.-2/कोर्ट-59/2013-712(2) dated 20.06.2014, enclosed as Annexure-3A of the prospectus of PGMAC-2024, duly issued by the Civil Surgeon of the concerned District and countersigned by the District Magistrate of the same District that he has rendered Govt. service in remote / difficult areas of the state.
- (c) Such Medical Officer in service, who claim benefit for serving in Remote / Difficult area are required to mention their claim, in the specified column of the Online Application Form otherwise the claim for this benefit will not be entertained.
- (d) If a candidate claims weightage of incentive marks for their remote services, the weightage will be given only to NEET(PG)-2024 qualified candidate. weightage will not automatically elevate a category candidate in to UR category due to addition of incentive marks. Their rank with incentive marks will be decided only in their basic qualified category.
- (e) As per notification of DGHS, New Delhi Ref. U-12021/01/2022-MEC, Dated 09-09-2022, candidate who wants to claim benefit for NRI quota should select "NRI" at the time of online registration of PGMAC-2024 and should submit the following documents with the required affidavit enclosed with the above notification as Annexure-1 at the time of document verification, otherwise they will not be eligible for NRI quota.
- · Documents claiming that the sponsorer is an NRI (Passport, Visa of the sponsorer).
- Relationship of NRI with the candidate as per the court orders of The Hon'ble Supreme Court of India in case W.P.(c) No. 689/2017-Consortium of Deemed Universities in Karnataka (CODEUNIK) and Ans. Vs Union of India & Ors. Dated 22-08-2017.
- Duly notarized Affidavit from the sponsorer that he/she will sponsor the entire course fee of the candidate and the relationship of the sponsorer with the candidate is in accordance with the above mentioned court order
- · Embassy Certificate of the Sponsorer (Certificate from the Consulate).
- NEET Score Card of the candidate.

5.5 There may be addition and deletion of the courses depending upon the situation. Any change in courses/ Institutions / Number of Seats and their status as communicated by the Deptt. of Health, Govt. of Bihar will be informed at the time of Counselling / Interview.

6. QUALIFICATION & ELIGIBILITY FOR MD/MS/PG DIPLOMA COURSES GROUP:

6.1 Educational:

- (i) The candidates must have passed the MBBS Examination from any Medical College of Bihar State which is established or financially aided by the State Government or established and run by private management / Corporation and included in the schedule of Medical Council of India/ National Medical Commission. For Private Medical Colleges, this criteria is liable to be modified in the light of ज्ञापांक-सं.

 1/ विविध- 74/2016-404(1) दिनांक 06.04.2019 and related directives or Department of Health, Govt. of Bihar (See Annexure-5).
- (ii) The candidates who are permanent residents / domiciled of Bihar and have been admitted in MBBS course on the basis of competitive examination conducted on behalf of Govt. of Bihar or by CBSE (under All India Quota) before the bifurcation of Bihar i.e. 15.11.2000 in Medical Colleges situated in Jharkhand and have obtained the degree of MBBS are also eligible for nomination / allotment of a seat for admission in academic session 2024.
- (iii) The candidates must have completed satisfactorily one year compulsory rotating Internship as on 15.08.2024.
- (iv) The candidates must have obtained permanent Registration from Medical Council of India or Bihar State Medical Council. A candidate, who has not obtained permanent registration from Medical Council of India or Bihar State Medical Council but is otherwise eligible, may be allowed to appear at PG Medical counselling 2024 on provisional basis but he must obtain the same within one month from the date of his admission in P.G.Course as per the rules of the Medical Council of India, failing which the admission of the candidate shall be cancelled. He must also be registered after admission under the concerned University within the period prescribed by that University.

6.2 Residential:

The candidates must be a citizen of India.

6.3 Others :

A candidate who is not a permanent resident of Bihar but has passed the M.B.B.S. Examination from any Medical College of Bihar State which is established or financially aided by the State Government or established and run by private management / corporation and included in the schedule of Medical Council of India / National Medical Commission is also eligible.

6.4 Age Limit :

There is no maximum age limit for appearing PG Medical Counselling 2024

6.5 No Objection Certificate:

A candidate who is in employment either in Government or elsewhere will be allowed to appear at the PG Medical Counselling 2024 only if he produces a certificate of "no objection" from his employer with the condition that if selected he will be granted study leave to pursue the course. However a candidate who is an employee of Government of Bihar shall be issued admit card provisionally in the absence of such "no objection" certificate. But on selection, he will have to produce relieving certificate from his controlling officer. Otherwise, he is required to furnish an undertaking/ affidavit that in case he is selected he shall resign from the service and shall undertake the studies as a full time student. Such affidavit/ undertaking is to be filed along with the application form. The relieving letter by the employer shall be submitted on or before the date of admission.

6.6 Training:

(i) All the candidates called for counselling/ interview, if selected, shall have to be registered with Bihar Council of Medical Registration / Medical Council of India within one month from the date of the admission in P.G.Course and will also have to be registered by the University concerned within the prescribed period by that University. The registered candidates will undergo whole-time training for 3 years and 2 years for degree and diploma courses respectively, from the date of their admission.

- (ii) The compulsory Rotating Internship must be from a Hospital/ Institution approved and recognised by the MCI / NMC.
- (iii) No admission or readjustment will be done after the last date of admission as fixed in compliance with the requirement of Medical Council of India .Thereafter, the seats remaining vacant if any, shall be treated to have lapsed. No transfer/ migration will be permissible after admission.
- (iv) An admitted candidate on the basis of PG Medical Counselling based on NEET (PG)-2024, shall automatically forfeit his claim to continue in the previous P.G.Course for which he was originally registered. His name registered for that P.G.Course will be cancelled and upon his/ her admission to the new P.G.Course on the basis of PG Medical Counselling based on NEET (PG)-2024, he will have to get registered with the university concerned for that P.G.Course only and he has to refund the entire amount of stipend already paid to him for the previous P.G.Course to the previous Institution and a certificate to this effect is to be produced at the time of counselling to the new Course, allowed to him.
- (v) Admitted candidates who remain absent continuously for more than 2 months are liable to forfeit his claim to continue in the previous PG Medical course for which he was originally registered. His name registered for that PG Medical course will be cancelled and upon his / her admission to this new PG Medical course on the basis of PGMAC-2024 he will have to get registered with the university concerned for that PG Medical course only and he has to refund the entire amount of stipend already paid to him for the previous PG Medical course to this previous institution and a certificate to this is to be produced at the time of counselling to the new course allover to him.

7. **RESERVATION:**

(A) (i) For the selection of candidates for admission in Post Graduate Degree/ Diploma Courses of MD/ MS / PG Diploma Course / DNB Course in Govt. Medical Colleges, the reservation Policy/ Rules of the Government of Bihar prevailing on the date of Online submission of Application Forms for PG Medical Counselling 2024 will be applicable.

Accordingly the reservation categories will be determined on the basis of the lists of SC, ST, EBC and BC as approved by the Govt. of Bihar and applicable on the date of the online submission of application forms for allotment of PG Medical seats on the basis of PG Medical Counselling based on NEET (PG)-2024 .

(ii) For the Candidates, who are permanent residents of Bihar State, reservation of seats for various Categories as per the policy of the Government of Bihar prevailing at the date of PG Medical Counselling 2024 is as given below –

The remaining 40% unreserved seats will be considered as Unreserved (UR) Category

seats. Note: (a)

- 10% Reservation for Economically Weaker Section will be provided as per the Extra Ordinary Gazatte of Bihar, Patna dated 26.02.2019.
- (b) Without affecting the provisions of vertical reservations, as applicable from time to time for admission in the educational Institutions in the Sate of Bihar, one third of total seats of all the courses and categoris in each Institution and College affiliated with the University shall

be horizontally reserved for admission of women candidates. In case of Post-Graduate courses it shall be applied at the State level specialty wise.

Provided that this benefit shall be available only to the women domiciled in the State of Bihar. In the absence of eligible women candidate, the vacant seats in the same academic session shall be filled up by the male candidates from the relevant category (reserved / unreserved).

- (iii) For the Candidates who are not the permanent resident of the State of Bihar, seats earmarked for the reserved categories as enumerated in Sl. No. 8(ii) above, will not be admissible, vide Department of General Administration, Government of Bihar letter no. 11/আ0-বিবিध-50/2011 মা০- 2710 dated 26.08.2011. They will be considered against General Category seats only.
- (iv) Candidates of reserved categories competing in General Merit List will not be counted against reserved category seats. Selection of the candidates in the unreserved category will also be on merit. Placement of Reserved Category candidates will be done as per the Government resolution/ orders applicable at the time of starting the sales of the Application Form for PG Medical Counselling 2024. Candidates of reserved category competing in General Merit List will have the option for general as well as the concerned reserved category seats for purposes of placements, but the seat of reserved category exhausted due to their option will be compensated from seats of General Merit List.
- (v) A candidate claiming admission on seats reserved for SC/ ST/ EBC/ BC will have to furnish (a) Residential certificate (b) Caste certificate from CO/Revenue Officer of the area of his/her permanent residence in the State of Bihar, as mentioned in the Application Form for appearing in PG Medical Counselling 2024.
- **N.B.:** (i) Caste and Residential Certificates issued by other than CO / Revenue Officer will not be entertained and will lead to rejection of his/ her application.

The Residential Certificate must mention that the candidate is a permanent resident (स्थायी निवासी) of Bihar giving his complete address, letter no. and date of issue. Certificates mentioning that the candidate is resident (निवासी) / temporary resident (अस्थायी निवासी) or incomplete in any respect will not be accepted.

- (ii) Caste certificate issued on the basis of the Caste of the Husband / Wife of the candidate is not acceptable. Caste Certificate issued on the basis of the caste of his / her father will only be accepted.
- (iii) The spelling of the name of the candidate written in his application form of NEET (PG)-2024 must be the same as written in his matriculation and other certificates. Any difference will subject to the decision of the concerned authority of the Deptt. of Health, Govt. of Bihar.
- (vi) The category, which a candidate claims for reservation in the space provided for this purpose in the Application Form and the Residential certificate and Caste certificate which be submits as per para (v) above, will be accepted for the PG Medical Counselling 2024 and the allotment of seats will be made on that basis provided the same are in conformity with the rank list of NEET (PG)-2024. Once the application form is accepted, no change will be allowed. In case the category claimed by a candidate and mentioned in the specified space in application form for appearing in counselling differs from that mentioned in the merit list as provided by the Deptt. of Health, Govt of Bihar based on NEET (PG)-2024, then the category as mentioned in the Merit List will be treated as final. If a candidate does not mention the category at the specified space in application form or does not submit the proper caste certificate in support of his claim for the reserved category benefit then he will be treated in General (GEN) i.e. UR (Unreserved) category. The responsibility of losing his reservation claim due to his mistake/ carelessness will entirely be his own.

(B) Reserved Seats under Disabled Quota (DQ):

(a) For disabled candidates, 5% out of the available seats in each Institution, are reserved under "Disable Quota". Such reserved seats are included in the total number of the available seats.

In this connection, if the state Government issues any other Government order before publishing the merit list for counselling / interview for the purposes of the seat allotment, then reservation rules according to the same Government order, will be applicable for admission under Disable Quota subject to his DQ (or PH) status is mentioned in merit list of NEET (PG)-2024.

(b) Each disabled candidate is required to mention his claim in the specified space of his application form such DQ candidates have to submit DQ Certificate at the time of counselling / document verification in the light of regulation on Graduate Medical Education (1997) as amended up to 14.05.2019, in the prescribed performa as enclosed in Annexure-1A of the prospectus. As per decision taken by concerned Department and BCECE Board, the candidate have to produce disability certificate only from the authorized centres, the list of which are mentioned in Annexure-1B and 1C of this prospectus. No other Disability Certificate issued by any other centre will be acceptable in any conditions.

Original DQ Certificate issued by the authorized centre as per Annexure-1B and 1C has to submit at the time of Document Verification . Counselling otherwise they will not eligible for DQ seat. This DQ Certificate is valid only for admission in different courses on the basis of examination conducted by the BCECE Board. It cannot be used neither for any other purpose nor for admission in any other institutions whose examination / admission is not taken by the BCECE Board.

- (c) A disabled candidate may opt on the basis of merit rank list of NEET (PG)-2024, any one of such courses for which his disability is within the limits of the acceptable disability standards and is not restrictive for opting the same. The admit order will be issued to the candidate after he is found otherwise medically fit.
- (d) "Guidelines for admission against Disable Quota" is enclosed as Annexure-ID.

8. Procurement for application form, prospectus and counselling fee & security deposit:

- 8.1. The Prospectus for appearing in PGMAC-2024 can be downloaded Online from the BCECE Board's website: beeceboard.bihar.gov.in by clicking on the link "PGMAC-2024" under Prospectus Section. For filling online Application Form click on "Online Application portal of PGMAC-2024" and then click on "Apply Online" button and follow the instructions as given below;
- I. Step-One Registration: For registering, the candidates are required to fill the information asked in Step-One of the application form, appearing on the computer screen. Candidate must enter their NEET-PG 2024 Roll No. and then click on verify button and then enter their Date of Birth and click OK to verify their details. If data gets verified then an OTP will be sent to their registered mobile no. and email ID. After verifying OTP, proceed for further process. Candidate's all informations concerning registration will be sent on their registered email ID and Mobile No. given in NEET-PG 2024 online application form. After successful Registration, candidate will receive a message of successful registration on their registered mobile no. and email. After that, candidate will have to login to their account by entering their NEET-PG-2024 Application no. and Password and will process the further activities to duly submit their online application form. The candidate must keep the password entered in Application Form confidential, otherwise BCECE Board will not be responsible for any changes in their data or any other complication etc. The NEET-PG-2024 Application No. provided to the candidate by NBE will be his "user name".
- II. Step-two (Personal Information): After successful registration and activating the account, the candidate should again "Sign in" to his account and thereafter complete the required entries regarding personal information on the computer screen. Then click on "Save & Continue" button.
- III. Step-Three (Upload Photo and Signature): After entering the personal information, the candidate should upload his / her passport size photograph as uploaded in NEET-PG 2024 online application form and full signature in Hindi and English (Not in capital letter) after duly scanning the same. After uploading photo and signature click on "Save & Continue" button.
- IV. Step-Four (Educational Information): After uploading the scanned photo and signature the candidate should enter his / her educational information on the computer screen and click on "Save & Continue" button.
- V. Step-Five (Remote Experience): After entering educational informations the candidate will have to enter the details regarding work experience as Medical Officer in remote / difficult area as well as to upload their work experience certificate issued by authorised concerned authority, if candidate claimed reservation for Medical Officer employed in remote / difficult area. For detail please see para-5.4 of the Prospectus of the PGMAC-2024.

VI. Step - Six - (Preview your application): After entering educational information / remote experience the candidate must verify all the information given by him / her while verifying given information in step-2, step-3, step-4 and step-5. If any information is found wrong, then the candidate should click "Back to Edit" button and make required corrections. Thereafter the candidate should click "Save & Continue" button so that entered information should be updated.

If preview of application form is found to be correct, then the candidate give his / her Declaration and click the "Proceed to Payment" button so that he / she should pay Counselling Fee and Security Deposit as per Step-Seven.

- VII. Step-Seven (Payment of Counselling Fee and Security Deposit): After previewing the Application Form for submitting the same, candidate should click "Proceed to Payment" button and complete the payment procedure for counselling fee and security deposite according to instruction appeared on the computer screen. Counselling fee is not refundable.
 - (a) Candidate has to pay Rs. 2200/-(Two Thousand Two Hundred Only) for all category as non refundable counselling/registration fee through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI.
 - (b) The details of payment of security deposit for Govt. / Pvt. Medical Colleges will be as follows;

As per above table, the candidate has to pay the refundable security deposit, if applicable, through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI at the time of registration and submission of the application form. The candidate has also to pay processing charge in addition to Counselling / Registration Fee and Security Deposit for payment through online mode.

Note: (i) If the amount paid as Examination / Counselling fee is debited from your account but the fee transaction fails, then in such a case you must re-pay the desired full fee and ensure the payment. If your required Examination / Counselling fee do not reflect in Board's account within the due date, your application form will remain incomplete and you will not be eligible for Examination / Counselling.

Your failed deducted amount from bank will be refunded to your account.

- VIII. Step Eight (Downloading of Part- A & Part-B): After payment of Counselling/Registration Fee and Security Deposit upto scheduled date and time, the candidate must download Hard Copy (Part-A & and Part-B) of online submitted Application Form and keep the same safely in his possession because it contains all informations provided by the candidate and the PGMAC-ID made available by the Board for further use during counselling.
- **Note:** a. Candidate must download the online filled Application Form (Part-A & Part-B). Hard copy of Part-A & Part-B need not to be send to Board's office, but instead this is to be made available at the time of counselling.
 - b. After completing the above procedure and after the date of editing and submitting the online application form, there is no provision for any change or modification in the same.
 - c. The candidate must note that after submission of online application form, neither it can be withdrawn nor any request for refund / chargeback of paid counselling fee will be entertained.
 - d. Board will not be responsible for any interruption in Internet / Banking system. Therefore the candidates must not wait for last date and complete all procedure before due date.
 - e. If any candidate does the payment of Counselling Fee / Security Deposit, but due to any technical issue the payment does not reflect and the amount got deducted from their bank account and even if due to any technical error sms or mail on their Registered Mobile and email id goes as "Application form submitted successfully" then in this case candidates are advised not to wait for payment updation instead do re-payment of counselling Fee/ Security Deposit else neither your application form nor candidature will be accepted.
 - f. Final Merit list will be prepared after scrutinising the candidate's submitted data from the data provided by National Testing Agency / Health Deptt., Govt. of Bihar and also under the rulese regulations of Hon'ble court, MCC and BCECEB.
 - g. The Rank Card / Merit List will be published on the Board's Website on scheduled date as notified through concerned advertisement.
 - h. Online Registration and submission of application for PGMAC-2024 will be one time i.e. before 1st Round Counselling. No other chance will be given to any candidate for Registration and submission of online application after due date for online submission of application.
 - i. Candidates are advised to confirm the Fee structure / any other additional Fee for the Pvt. Colleges before filling up online Application Form. As Pvt. Colleges have high Fee structure, therefore candidates must confirm the Fee structure before Registration and Submission of Application Form from either the website of BCECE Board or concerned colleges. BCECE Board takes no responsibility of the fee structure of the colleges and will not entertain any complain regarding Fee structure.
 - j. After online submission of application, candidates will not be given any opportunity to edit / rectify any entries including Photo/ Signature as there is very short period for One time Registration process. Hence, all candidates are advised to ensure the correctness of their entries, for which the candidate will himself be responsible.
- 5. Such candidates who claim for NRI Quota must upload their Certificates as per clause 5.4(e) of the Prospectus of PGMAC-2024 in a

single .pdf File not exceeding more than 2 mb file size, After scrutny of uploaded NRI Certificate, the candidate will be declared eligible / ineligible for NRI Quota Seat.

- 6. Such candidates who claim for benefit of weightage for admission in Post Graduate Medical courses, who served in rural area for at least 2 years against **floating post** of medical officer (contractual) have to upload their relevent documents in a single .pdf file not exceeding more than 2 mb file size After scrutny of uploaded documents, the candidate will be declared eligible / ineligible for benifit against floating post of medical officer.
- 7. (a) DQ candidates must note that they have to submit DQ certificate issued by only authorised Centres / Institutes on prescribed proforma as per para-7B (Annexure-1A, 1B, 1C) of the prospectus of PGMAC-2024 at the time of counselling / document verification. For this, after filling and downloading the hard copy of online application form, candidates must consult any concerned authorised Medical College / Centre / Institute with the downloaded online application form for disability test for obtaining disability certificate.

Certificate issued from any other Institutes / Centres except above will **not be entertained**, for which the candidate will himself be responsible.

7. The Health Department, Govt. of Bihar vide letter no.-सं०सं०-01/प०नि०-05-2024-499(1) dated 07.07.2023 has informed that in the light of Sankalp No.-187(1) dated 14.03.2023, to bring uniformity in Admission and other fees for admission in Degree, Post Graduate Degree and Super Speciality Courses in all Govt. Medical Colleges of the State rescheduling of Admission and other fees and in accordance with the provision of NMC, New Delhi, the admission and other fees for admission on 50% seats of Degree and PG Degree courses of Private Medical Colleges and Deemed University will be same as rescheduled fees for Govt. Medical Colleges has been approved. In the light of above, necessary action be taken.

As communicated by the Department of Health, Govt. of Bihar vide letter no. -মাতমত-০1/৭০লি০/০6-2024-700(1) dated 14.10.2024 that decision taken vide departmental letter no. 497(1) dt. 21.08.2024, it has been decided to keep the above condition in obeyance for admission in Post Graduate Medical courses for the academic year 2024-25 also.

8.6 Submission of the Application Form (Hard Copy - Part-A and Part-B) and required documents during Counselling / Document Verification:

After allotment of seat, the candidate has to present himself physically at reporting centre for document, eligibility and identity verification with the application form (Hard Copy - Part-A and Part-B) alongwith required original documents with their self attested photo copies etc. After due verification/ checking and establishing the identity as well as eligibility of the candidate, admission will be taken / confirmed.

9. METHOD OF SELECTION AND ADMISSION:

- 9.1 9.1 Merit List:
 - a) Merit list of all the qualified candidate as provided by the Deptt. of Health, Govt. of Bihar based on NEET (PG)-2024 will be the basis for PGMAC-2024.
 - b) There will be four (4) round of Counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy Round.
 - c) All round Counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy round will be Online.
 - d) For Round-3 Online Counselling Fresh online Registration & submission of Application Form, from those candidates who have not Registered and submitted Application Form of PGMAC-2024 earlier i.e. before 1st round Counselling, will be taken. Details will be made available through concerned advertisement.
- 9.2 (i) (a) On the basis of merit list of eligible candidates, the candidates have to fill their choices online for PGMAC-2024 counselling. Please note that registration and choice filling facility will be available as per schedule published in concerned Advertisement. After completion of choice filling process, seat allotment will be published on Board's website. In case candidate is allotted a seat during 1st round seat allotment, he / she has to report physically at reporting centre for document verification. After document verification, if he is found eligible he will either take admission or go for **free exit**. But if he has given willingness for upgradation during downloading of 1st round provisional seat allotment order then after document verification, he will wait for 2nd round seat allotment and his submitted document will be retained at reporting centre.

But if his choice is upgraded in Round-2, then the candidate will have to join the college on allotted seat during second round. If candidate does not join the Institution / seat allotted during 2nd round within scheduled period, his / her refundable security deposite will be forfeited.

- (b) Candidate who did not get any upgradation in Round-2 will continue to study in the same college and seat.
- (c) Fresh choice filling can be done for Round-2 & Round-3 by those candidates;
 - (i) Who completed the registration process for Round-1 / Round-2, but did not filled the choices due to any reason.
 - (ii) Who have been allotted a seat in Round-1 but has taken free exit.
 - (iii) Fresh Registration-cum-choice filling can be done for Round-2 & Round-3 by those candidates, who have not completed the registration process during earlier Rounds due to any reason.
- (d) Modification in choice filling by logging in his previous registration details can be done for Round-2 & Round-3 by those candidates;
 - (i) Who have filled the choices in Round-1 but has not been allotted any seat in Round-1.
 - (ii) Who have filled the choices in Round-1 and has been allotted seat but given his willingness of upgradation, then in such case the candidate will have the facility to Swap / Add / Up / Down their choices, but he will not have the facility to Remove / Deleted their Round-1 allotted choice from the choice list.
 - (iii) Who have filled the choices in Round-2 and has been allotted seat but given his willingness of upgradation, then in such case the candidate will have the facility to Swap / Add / Up / Down their choices, but he will not have the facility to Remove / Delete their Round-2 allotted choice from the choice list. Admitted candidates of Round-2 opting for Round-3 can do so with forfeiture of his security deposit.

- (e) Last Round will be the Stray Vacancy round. Candidates have to make Fresh Registration with security deposit and fill New Choices for this round. Candiates admitted through Round-1 & Round-2 and also candidates allotted a seat through NEET(PG)-2024 in Round-3 anywhere in India are not eligible for this round as per NMC (MCC) guidelines.
- (f) On the basis of online choice filling of the candidate, provisional seat allotment order will be issued. Final seat allotment/admission will be subject to verification of their identity and original certificates at reporting centre fixed by the Board.
- (g) Before downloading of provisional seat allotment order, it is necessary for those candidate who want to upgrade their allotted seat, he has to give willingness for upgradation as "Yes" else "No".
- (h) If a candidate wants to avail free exit from allotted seat in round-1 of the counselling, even then he has to report at his reporting centre for document verification and submit their original doucments.

For free exit the candidate has to inform the head of institution in writing, then only all his certificates will be returned. Also the seat allotted to the candidate will be declared vacant for allotment in 2^{nd} round. Option of free exit can only be exercised after allotment of round-I till the prescribed date. Free exit candidates are eligible for allotment in 2^{nd} round. But if the candidate is allotted the same seat in round-2, but does not join, his security deposit will be forfeited.

- (i) If a candidate has opted for Upgradation in Round-1 but if his seat of Round-1 is retained in Round-2, this seat will now be treated as Round-2 seat.
- (j) A candidate who has filled his choices online for PGMAC-2024 counselling within the prescribed period and could not get any seat either in Round-1 or Round-2 or Round-3 of the PGMAC-2024 counselling, then his security deposit amount will be credited in his bank account from which he has deposited the same after end of all round of counselling.
- (k) Candidates are advised to visit official BCECE Board https://bceceboard.bihar.gov.in/ website regularly for latest updates.
- ii. Institution / course / subject / category wise seat matrix is available as schedule [Table-1, 2, 3 & 4].
- iii. For admission in reserve categories, all Institutions will be considered as one unit.
- iv. Dates and venue of documents verification by personal appearance will be available on provisional allotment letter, candidate should bring all relevant original documents as mentioned in prospectus of PGMAC-2024 at the time of document verification, along with a set of photo state copy of each certificate / document.
- v. A candidate, if found eligible in all respect after due verification of his documents and identity, will have to join the course within prescribed period of time failing which the candidature of the candidate may be rejected and deposited security deposit will be forfeited
- vi. The candidates belonging to unreserved category have to secure at least 50 percentile marks and candidates belonging to SC, ST, EBC & BC reserve categories at least 40th percentile marks in the competitive test of NEET (PG)-2024, in order to fulfil the minimum performance criterion as fixed by the National Medical Council to be eligible for admission in any Post Graduate course.
- vii. No candidate will be permitted to pursue and complete more than one course from the same Examination [NEET (PG)-2024] and the same session.
- viii. No candidate will be enrolled for two courses simultaneously i.e., as a regular student for one course and as an ex-student for the other course.
- ix. A candidate who has passed a degree course will not be permitted admission in diploma course of that subject.
- x. If a candidate has been admitted in a P.G. Degree / Diploma courses i.e. MD/MS/PG Diploma / DNB in any speciality on the basis of an earlier P.G. Medical Admission Test, then he may be allowed to appear at the current P.G. Medical counselling but will not be eligible for admission in a P.G. Degree / Diploma course of MD/MS/PG Diploma / DNB of another speciality unless:-
 - (a) He resigns and vacates the seat of P.G. Degree/ Diploma courses of MD/MS/PG Diploma / DNB against which he / has been admitted earlier, within seven days of receiving of the allotment / nomination order on the basis of current PG Medical Counselling based on NEET (PG)-2024.
 - (b) He returns all the pecuniary benefits taken thereof for the earlier course.

- (c) He is liable to pay compensation for leaving the earlier course if the final decision regarding the same is made by the Government before the commencement of the counselling based on the current PG Medical Counselling based on NEET (PG)-2024.
- xi. Regarding Bond etc at the time of taking admission in allotted PG Medical Courses in Govt. Medical College of Bihar. Please see संकल्प 1/विविध- 58/2015-450(1) dt. 15.04.2017. Corrigendum no.1/विविध-58/2015-479(1) स्वा., पटना दिनांक 26.04.2017 and संकल्प-सं.सं.-1(विविध)-58/2015-278(1), Deptt. of Health, dt. 27.02.2019 which isannexed as Annexure-4 4(i) & 4(ii).

10. GENERAL INSTRUCTIONS:

(i) Any candidate if reported to have committed unfairmeans / impersonation at any stage during the process of selection for PG Medical course, shall be liable for legal action at any stage before or after admission under Bihar conduct of Examination Act, 1981 and other relevant Acts. Under the provisions the candidate may be expelled and debarred from appearing in the process of nomination for a seat of PG Medical Course.

As per Bihar Conduct of Examination Act-1981, "Unfair Means" in relation to any examination shall mean taking or giving or attempting to take or give help from any material written or printed or from any person in any form whatsoever.

- (ii) Submission of incorrect/ false documents / informations and adoption of unfair means/ impersonation, if detected at any stage after the selection for admission at any later stage shall automatically lead to rejection of the candidature of the candidate for admission.
- (iii) The candidates whose Roll / Name appeared in the merit list based on NEET (PG)-2024 will have to appear in person at his own cost for scrutiny and verification of the original documents/ his identity and for Interview/ Counselling on the scheduled date and time, failing which his claim for allotment of a seat will be rejected. It is to be noted that Interview / Counselling is being conducted as per the directives of the Department of Health, Government of Bihar.
- (iv) Appearance in person for scrutiny of original certificate / documents during Interview/ Counselling does not entitle a candidate for allotment / admission.
- (v) If by mistake, a candidate is allowed to appear at the PG Medical Counselling 2024 which, otherwise, would not have been possible and the error is detected subsequently at any stage before or after the admission, he will lose all claim/ right of admission even if he competes successfully. In case of any legal dispute arising out of the situation, the candidate will not be admitted till the final disposal of the case.
- (vi) If a candidate needs any special information in addition to what has been provided in this prospectus regarding any Course / Institution or else, he should either contact the Institution directly or the Deptt. of Health, Govt. of Bihar.
- (vii) Information regarding any subsequent modification / alteration / addition / deletion made in the provisions of the prospectus will be given to the candidates during the counselling or earlier, as far as possible.
- (viii) In all matters relating to PG Medical Counselling based on NEET (PG)-2024, the decision of the Deptt. of Health, Govt. of Bihar through Controller of Examination, Deptt of Health, Govt. of Bihar-cum-coordinator NEET (PG)-2024 will be final.
- (ix) A candidate on being finally selected must join the course within stipulated time, otherwise the candidate will forfeit his claim for admission and his security deposite will be forfeited.
- (x) If in service, the candidate shall have to resign from service or obtain leave for the whole period of study and get himself/ herself relieved before joining the course.
- (xi) The Government of Bihar reserves the right not to take any admission in any subject or in any course and to make any addition/ deletion in the courses as and when required.

- (xii) Any instructions through advertisements / website / general notice will form part of this prospectus.
- (xiii) Any error in NEET (PG)-2024 / PGMAC-2024 merit list will not entitle the candidate for admission.
- (xiv) Those who do not turn up for Counselling/Interview and the verification of documents in person on the notified date will forfeit their claims for admission.
- (xv) After the declaration of the closure of admission process, the remaining vacant seats in any course of the Institution concerned will not be filled up.
- (xvi) If any modification / command required after any order / directive of the Hon'ble Court / NMC / Govt. of India / Govt. of Bihar with reference to the allotment in PG Medical Courses for the session-2024 is received in future, the same will be implemented from immediate effect.
- (xvii) Bihar Combined Entrance Competitive Examination Board reserves the right to change / modify / add/ delete any rule / information for purpose of conducting PG Medical Counselling based on NEET (PG)-2024.
- (xviii) In case of any discrepancy / confusion in counselling the guidelines issued by NMC, New Delhi will be followed.
- 12. If it is detected that the candidate is not otherwise qualified, or has incurred any disqualification making him ineligible for admission to the course his claim for allotment / nomination of a PG Medical seat will be rejected.
- 13. Refund process of security deposit (to whom applicable) will start only after the completion of all rounds of counselling. BCECE Board will not entertain any query either through email or phone call or correspondence with regards to refund of security deposit before the completion of all the rounds of counselling including / Stray Vacancy counselling.
- 14. It has come to the knowledge of the Board that there have been instances wherein some persons / agents have claimed to provide a seat in any of the participating colleges of Bihar during the Counselling process and there after. The candidates are advised to not fall prey to the said claims as there is no direct entry / nomination in any of the participating colleges in the PGMAC-2024.
- 15. Any dispute arising out of or connected with PGMAC-2024 shall be subject to the jurisdiction of Hon'ble Patna High Court only.
- **16.** Updated Rules of NMC / MCC will be followed.
- 17. All concerned Advertisement and Notification will be treated as part of this Prospectus.

No.MCI-34(41)/2019-Med./112862.— In exercise of the powers conferred by Section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Board of Governors in super-session of Medical Council of India with the previous sanction of the Central Government, hereby makes the following Regulations to further amend the "Graduate Medical Education Regulation, 1997", namely: —

- 1. (i) These Regulations may be called the "Graduate Medical Education Regulations, (Amendment), 2019".
 - (ii) They shall come into force from the date of their publication in the Official Gazette.
- 2. In the "Regulations on Graduate Medical Education, 1997", in Appendix "H" Guidelines regarding admission of students with "Specified Disabilities" under the Rights of persons with Disabilities Act, 2016 with respect to admission in MBBS –shall be substituted with Appendix "H-1".

The "Certificate of Disability" shall be issued in accordance with the Rights of Persons with Disabilities Rules, 2017 notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 15th June 2017.
 - 2. The extent of "specified disability" in a person shall be assessed in accordance with the "Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016 (49 of 2016)" notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 4th January 2018.
 - 3. The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability.
 - 4. The term 'Persons with Disabilities' (PwD) is to be used instead of the term 'Physically Handicapped' (PH).
