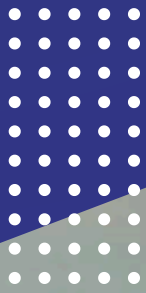

# ABOUT



## DR. B. R. AMBEDKAR NATIONAL LAW UNIVERSITY, SONEPAT

Dr. B.R. Ambedkar National Law University (earlier known as National Law University Haryana), Rai, Sonapat (hereinafter abbreviated as DBRANLU) was established by the State Government of Haryana in the year 2012 vide State Legislature Act No. 15 of 2012. DBRANLU is the first fully residential National Law University in Haryana. As a tribute to Bharat Ratna Dr. B. R. Ambedkar, a great visionary, social reformer and architect of our present legal system and craftsman of our Constitution, the State Legislature of Haryana through an amendment in 2014, changed the name of the University to Dr. B.R. Ambedkar National Law University, Rai, Sonapat. A state-of-the-art campus has been constructed in the education hub of India –Rajiv Gandhi Education City, Rai, Sonapat falling under National Capital Region – where more than thirteen renowned educational Institutions/ Universities are located. The University provides a positive and congenial environment for legal education and professional training besides the overall development of students. It is well connected by Air, Rail and Road to all major points of State and the Nation with a distance of approx. 30 KMs from National Capital Delhi, and approx. 215 KMs. from State Capital Chandigarh. The University has been approved by the Bar Council of India (BCI) since 2019. It got registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956.

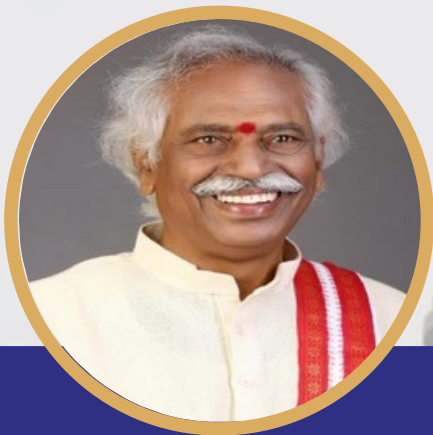
DBRANLU is offering B.A.LL.B. (Hons.) Five-Year Integrated programme.

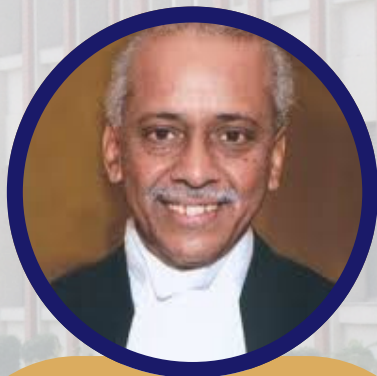

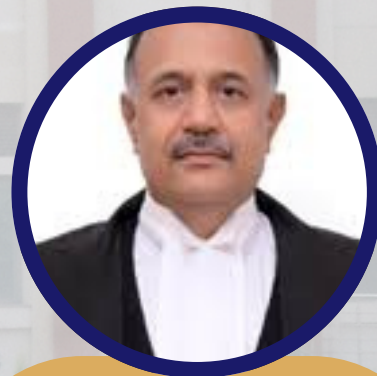

# ADMISSION PROCEDURE

## ELIGIBILITY FOR ADMISSION

The Admission is based on the merit through the Common Law Admission Test (CLAT). However, to qualify for admission:-

1. The candidate must have passed 10+2 examination of the Board of School Education, Haryana or its equivalent State/Central Board with minimum 45% marks in the aggregate (40% marks for SC/ST candidates)

OR

The candidate must have passed 10th with two year diploma course or one year diploma course with one year apprenticeship from the ITIs recognized by the Skill Development & Industrial Training Institutes Department, Haryana, with Hindi or English as an additional subject from the Haryana Board of School Education, Bhiwani.

2. The candidates appearing in or awaiting results of the qualifying examination held or being held in March/April 2024 may also apply and appear for the Common Law Admission Test (CLAT) provisionally, subject to the condition that they shall produce the proof of having passed the qualifying examination with the prescribed percentage of marks and other requisite documents at the time of their counselling for admission at DBRANLU, Sonapat.

3. The candidature of:

- a) Those who do not clear the qualifying examination with the requisite marks and or fail to produce the result on the date of counselling, or
- b) Those who get compartments/re-appear in any subject in the qualifying examination shall be cancelled and subsequent securing qualifying marks shall not be considered in any case.

A candidate applying in any type of reserved category is required to submit a category certificate issued by the competent authority on the date and time of Counselling.

1. Candidate applying in any type of reserved category is required to submit category certificate issued by the competent authority.
2. The candidate applying under WL category shall have to produce a certificate mentioning that his/her or his/her ancestral land has been acquired under the land acquisition policy of Rajiv Gandhi Education City, Rai, Sonapat. The said certificate should be duly verified by the concerned Tehsildar.

3. The allocation of the candidates to DBRNLU, Sonapat by the CLAT Authority through the Centralised Admission process shall be provisional subject to verification of original certificates/ testimonials and documents by DBRNLU. Therefore, candidates are required to submit the admission form available in the DRBANLU Prospectus along with the attested copies of the documents/certificates.

4. The Candidates are required to produce original Certificates / Documents on the date of the interview/ counselling. Failure to produce Certificates/Documents in original shall result in cancellation of their candidature.

5. Conversion of reserved seats into the general category: In case of non-availability of the candidate in the reserved category, the vacant seat(s) shall be converted as under:

(i) On non-availability of a ST candidate, the seat shall be converted into the SC Category

(ii) On non-availability of SC candidate, the seat shall be converted into General Category

(iii) On non-availability of DSC candidate, the seat shall be converted into SC Category

(iv) On non-availability of an EWS Category candidate, the seat shall be converted into the General Category

(v) On non-availability of WL category candidate, the seat shall be converted into the UR-HR Category

(vi) In the event of the quota reserved for PWD remain unutilized due to non-availability for the suitable category of handicapped candidates, it shall be offered to the Ex-servicemen and their wards and the dependents of Freedom Fighters as per Haryana Govt. Reservation Policy.

# HOSTELS

Dr. B. R. Ambedkar National Law University started its first academic session in July 2019. The University is functioning from its main campus i.e. Plot No. 5, Rajiv Gandhi Education City, Rai, Sonapat, Haryana.

Boys and Girls Hostels are under the overall supervision of the Chief Warden. He/She is assisted by the team of Wardens and Hostel Supervisors. All admitted students have to reside in University Hostels.

Hostels are constructed on the latest modern pattern. These are equipped with all facilities and equipped with neat & clean mess/dining facilities. Hostels have 8 floors which are approachable through lift and stairs. The needs of Specially Abled Persons are also kept in consideration and hostels are comfortable and accomodable for them. Hostels are also equipped with Water Purifier systems attached with water coolers to ensure pure drinkable water supply, 24 hours power backup. Proper hygiene and sanitation are maintained by the housekeeping service. The hostels have round-the-clock security cover and all the hostels are equipped with Wi-fi connection. The hostel rooms are furnished with bed(s), study table(s), and study chair(s). Every room has been provided with wardrobe(s) having sufficient storage capacity. Hostels have rooms for both single accommodation and double-accommodation. The rooms are allotted as per the policy of DBRANLU. There are recreational facilities for the hostlers like Table-Tennis Boards, Televisions, Carrom Boards etc.

# LIBRARY

Our university provides a well-designed, spacious, separate library premise with air-conditioned reading halls with adequate seating capacity. The DBRANLU Knowledge Resource Centre is an example of excellence regarding amenities and collection. This is a fully computerized Wi-Fi Knowledge Resource Centre. DBRANLU Knowledge Resource Centre has subscribed to many E-resources including Manupatra, Westlaw, JSTOR Full package, Lexis-Nexis, EBC Reader, and Live Law, which are also available in print forms.

DBRANLU Law Review is an online peer-reviewed and biannual journal of DBRANLU. The journal is dedicated to advancing legal scholarship and fostering intellectual discourse within the legal community. The journal aims to serve as a platform for the dissemination of high quality research and innovative perspectives across various domains of law. # RESEARCH CENTRES

The eleven Research Centres were established in 2023. These centres work on the most socially pressing and relevant issues. The established centres are multidisciplinary undertakings and bring together theoretical and practical excellence. DBRANLU has actively developed and organised its research infrastructure to consolidate and augment research output in terms of publications, projects, and contribution to policy frameworks. Continuing our research efforts, DBRANLU entered into a number of collaborations

## **1. CENTRE FOR PUBLIC POLICY AND GOOD GOVERNANCE (CPPGG)**

This centre stands for propelling research endeavors, instigating scholarly debates, and nurturing practical proficiencies in diverse facets of public policy and governance frameworks. CPPGG embodies a dynamic entity, zealously dedicated to amplifying scholarly discourse and professional acumen in the sphere of public policy. Through rigorous scholarly inquiries, the center endeavors to incubate innovative strategies for addressing intricate societal challenges and advancing the collective welfare. It orchestrates specialized seminars, workshops, and capacity-building initiatives catered to students, policymakers, and stakeholders, nurturing a nuanced understanding of policy paradigms and governance dynamics. Moreover, CPPGG orchestrates a plethora of outreach initiatives encompassing symposiums, colloquiums, and advocacy campaigns to galvanize public engagement and amplify awareness on pertinent policy issues. ### **4. CENTRE FOR CONFLICT MANAGEMENT AND DISPUTE RESOLUTION (CCMDR)**

The CCMDR is a multifaceted organization that promotes educational and professional development in conflict resolution. It conducts scholarly research to develop innovative solutions to complex conflicts and offers specialized courses, workshops, and training programs for students, legal professionals, and practitioners. These initiatives provide practical skills, theoretical insights, and ethical principles for effective conflict resolution practice. The centre also engages in outreach activities, such as seminars, conferences, public lectures, and awareness campaigns, to promote peaceful conflict resolution and the benefits of Alternative Dispute Resolution (ADR). It encourages dialogue among stakeholders, fostering understanding and constructive approaches to conflict resolution. The centre also contributes to policy formulation and the adoption of ADR practices in various sectors. Its mission is to uphold ethical standards and principles in conflict resolution practice, upholding values like integrity, impartiality, confidentiality, and respect for the autonomy and dignity of parties involved in disputes.

### **5. CENTRE FOR GENDER JUSTICE & HUMAN RIGHTS (CGJHR)**

Centre for Gender Justice & Human Rights is committed to create the space for academic discourse on the varied perspectives of gender justice and human rights. It endeavours to administer programmes directed towards addressing the challenges and concerns of gender equality and protection of human rights. The legal discourse, comprising laws, policies, and judicial decisions, plays a crucial role in shaping societal norms, enforcing rights, and ensuring justice. It aims to expand opportunities for all genders and create better opportunities for them, without any bias. The Centre aims to bring a positive and reformative change in the society, and free people from the vicious cycle of discrimination and protecting the human rights.

## **6. CENTRE FOR CRIMINAL LAW RESEARCH & ADVOCACY SKILLS (CCLRAS)**

CCLRAS, at DBRANLU, is established with the object of conducting & promoting research in criminal law in India. Further, the Centre disseminates & promotes stimulation based practical learning of criminal law advocacy skills. The Centre is headed by Director and consists of student members.

In contemporary times, research skills are essentially required for a legal professional to succeed in the profession. It will always be an asset for a law graduate to have legal research skills in either of its sub-discipline; the Centre aims at teaching research skills in the area of criminal law that will be helpful for the students in the field of litigation, public-policy, & judicial services. Further, the Centre runs two intra-university training-cum-competitions, viz., Criminal Trial Advocacy Competition (CTAC), & Criminal Appeal Competition (CAC). Both competitions run for over six months in which training on criminal law advocacy skills is imparted through ‘workshops’ and ‘stimulation-based activities’.

## **7. INCUBATION CENTRE FOR LEGAL & INTER-DISCIPLINARY ENTREPRENEURSHIP (ICLIDE)**

Innovation and entrepreneurship skills have become the buzzwords in education sector in last couple of yrs. With more & more fresh law graduates finding it difficult to hold their feet in legal profession during couple of initial yrs., it becomes important for the law universities to make them self-sustainable when they complete their graduation. The Centre is established with the purpose of imparting entrepreneurship skills among the law undergraduates. The Centre, further, assists the students in establishing their own venture in legal & inter-disciplinary fields, like, establishing a public-policy organization, or, establishing a law firm. Experts from the field of entrepreneurship are invited to hone the required skills among the students who are interested to start their own venture when they will graduate. It is an effort on part of the University to guide & assist its students in building their own venture.

## **8. CENTRE FOR DISASTER MANAGEMENT & LAWS (CDML)**

Centre for Disaster Management and Laws (CDML) is established with an objective to understand disasters and laws regulating them. The center through different sources such as newsletter, blogs etc. aims to spread the awareness regarding various disasters irrespective of its impact. As India is vulnerable to disasters, comprehensive research on disaster management is important as this would assist the governments in making better laws and policies. The center aims to cater to the advancement of knowledge in disaster management and to respond to the sectoral needs and promote positive practices.

## **9. CENTRE FOR IPR & INNOVATION**

IPR Centre has been established for providing guidance on myriad aspects of IPR focusing on promotion and dissemination of knowledge on legal issues relating Intellectual Property Rights (IPR). . This center is dedicated to exploring the intersection of law, technology, and creativity, and to providing leadership in shaping intellectual property policies and practices. Through interdisciplinary research, educational programs, and outreach initiatives, the centre seeks to enhance understanding of intellectual property laws and their role in fostering innovation, economic growth, and cultural development.

## **10. CENTRE FOR CONSTITUTIONAL LAW AND TRANSFORMATIVE STUDIES (CCLTS)**

The Centre for Labour Studies will endeavour through research, training and publication to reach all those who are concerned with different aspects of labour both in the organised and unorganised sectors.

The centre's focus area would be various issues related to labour regulations and governance. The objectives of the centre are as follows:

- To engage in research and advocacy of law related to employment laws.
- To understand research on domestic and international employment laws.
- To study the emerging jurisprudence of employment in domestic and international contexts.
- To research the legislative-judicial interface of policymaking and its impact on employees.

In connection with this, the centre will undertake research, organise seminars, and workshops and engage with stakeholders on specific issues of rights of workers.

# ANTI-RAGGING REGULATIONS

**The University highly condemns the act of Ragging and take strict measures against those who are found guilty for the same.**

**What Constitutes Ragging? Ragging constitutes one or more of any of the following acts:**

- a) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- b) Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c) Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- e) Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- g) Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h) Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- i) Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher.
- j) Any other act/omission as per UGC Regulations 2009 and amended time to time

## **Punishment Provisions:**

Any student or group of students found guilty of ragging, whether on campus or off campus, shall be subject to one or more of the following punishments:

1. Debarring from appearing in any sessional test or university examination, or withholding of results.
2. Suspension from attending classes and academic privileges.
3. Withdrawing scholarships and other benefits.
4. Suspension from the college for a period of one month.
5. Cancellation of admission.
6. Debarring from representing the institution in any national or international meet, tournament, youth festival, etc.
7. Suspension or expulsion from the hostel.
8. Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period.
9. Expulsion from the institution and consequent debarring from admission to any other institution.
10. Fine up to twenty-five thousand rupees.
11. Imprisonment for a term which may extend to two years, or with a fine which may extend to ten thousand rupees, or with both.
12. Collective punishment: When the students committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

Any institution that fails to take adequate steps to prevent ragging, or fails to act in accordance with the regulations, or fails to punish perpetrators or incidents of ragging suitably, is liable to the penalties and punishments as per the provisions of the regulations.

**NOTE:- All the Students shall submit an Anti-Ragging Affidavit available on the U.G.C. Website Cross-Signed by Parents/Guardian at the time of Admission.**
